The new windows will be doublehung wood with Simulated True Divided Light (STDL) muntins to match existing. All new window trim will be wood to match existing. See attached exhibits labeled 'Window Details – April 2016' and 'Left Elevation – April 2016.'

If a building permit is not required, then the approved work must be completed within twelve (12) months of the date of issuance of this Certificate. In either situation, the Certificate can be renewed for an additional twelve (12) months by Historic District Commission staff by written request within the first twelve (12) months from the date of issuance.


