**DETAILS OF APPROVED PROJECT:** The project is the removal of an existing deck, construction of a new covered porch and deck rear addition, and replacement of the brick entry stairs on the left side. The new covered porch and deck rear addition materials are wood with the roof and all trim details to match existing. The rear pediment design and materials will match the front porch pediment. The new covered porch measures approximately 21' x 20' and the new deck measures approximately 9'-5" x 12'-9"see attached exhibits labeled 'Site Plan – October 2016', 'Covered Porch/Deck Floorplan – October 2016,'and 'Rear Elevation – October 2016.' The deck rail is wood comprised of 2x2 pickets that die into a horizontal rail at the top and bottom with an additional horizontal piece of trim on top. The brick stairs to the left side entry will be replaced in-kind. The exterior of the house will also be repointed, where required, with mortar to match existing.


