**DETAILS OF APPROVED PROJECT:** The project includes the reconstruction of the dilapidated front porch flooring and rails. The new porch floor is wood tongue and groove aligned perpendicular to the front thermal wall of the house, to match the original porch floors. The new wood porch rails will match the original rails in design, dimension, and material, with the pickets centered between the tapered top rail and the bottom rail. The original front door will either be repaired or replaced with a new wood door to match existing in design, see attached exhibit labeled 'Front Door Design – October 2017.' The rear entry door will be replaced with a new wood door, see attached exhibit labeled 'Rear Door Design – October 2017.' This approval does not include any other changes to the building (including windows) or site (drive, fence, etc.).

This Certificate is valid for a period of twelve (12) months from the date of issuance. Failure to obtain a building permit in that time will be considered as a failure to comply with the Certificate and the Certificate will become invalid. If a building permit is not required, then the approved work must be completed within twelve (12) months of the date of issuance of this Certificate. In either situation, the Certificate can be renewed for an additional twelve (12) months by Historic District Commission staff by written request within the first twelve (12) months from the date of issuance.




