DETAILS OF APPROVED PROJECT: Accessory Building. The project is a new garage, with second floor storage, located in the rear yard. No trees will be removed. The new building will meet all required setbacks and will be no wider and no taller than the main structure. The building footprint is approximately $31'-8'' \times 22'-2''$ and the height, as measured from grade to ridge, is $25' - 3 \frac{3}{4}$ ". The new garage will have a masonry foundation with wood Dutch lap siding in dimensions to match the house. All trim details, including corner boards, will be wood. All windows will be double-hung wood or wood-clad with Simulated True Divided Lights (STDL) molded muntins in a 6/1 pattern. The garage doors will be carriage style with square STDL windows. The second-floor dormer will set-in 0'-6" on the left and right elevations; and at least 1'-0" on the front and rear elevations. Post-completion, the rear yard permeable space will be approximately 58%. See attached exhibits "Drawings – March 2019" <u>AMENDMENT (3/20/19)</u>: See attached exhibit. Dormer will sit-in 0'-6" from the rear and front. Dormer will sit-in at least 1'-0" from left and right, as drawn.


- This Certificate of Appropriateness (COA) indicates that this project proposal has been determined to comply with the standards and policies of the Charlotte Historic District Commission.
