**AN ORDINANCE AMENDING APPENDIX A  
OF THE CITY CODE –ZONING ORDINANCE**

**ORDINANCE NO.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:**

Section 1. Appendix A, "Zoning" of the Code of the City of Charlotte is hereby amended as follows:

**A. CHAPTER 9: GENERAL DISTRICTS**

**1. PART 1: TABLE OF USES**

- a. Amend Table 9.101 by 1) adding “tattoo establishment” under the “Office and Business Uses” category as a use by right in the B-1, B-2, BD, BP, U-I, I-1, I-2, and TOD zoning districts, 2) as a use allowed with prescribed conditions in the UMUD zoning district, and 3) modifying the language in the table to match the text under the UR-C zoning district. The revised tables shall read as follows:

**2. PART 8: BUSINESS DISTRICTS**

- a. Amend Section 9.802, “Uses permitted by right”, by adding a new item (86.3) titled “Tattoo establishment” to the list of uses allowed by right. The new item shall read as follows:

(86.3) Tattoo establishment.

3. PART 9: UPTOWN MIXED USE DISTRICT

- a. Amend Section 9.903, “Uptown Mixed Use District; uses permitted under prescribed conditions”, by adding a new item (17) titled, “Tattoo establishment, subject to the regulations of Section 12.545”. The revised item shall read as follows:

(17) Tattoo establishment, subject to the regulations of Section 12.545.

4. PART 10: URBAN INDUSTRIAL DISTRICT

- a. Amend Section 9.1002, “Urban Industrial District; uses permitted by right” by adding a new item (11) titled “Tattoo establishment” to the list of uses allowed by right. The new item shall read as follows:

(11) Tattoo establishment.

5. PART 11: INDUSTRIAL DISTRICTS

- a. Amend Section 9.1102, “Uses permitted by right” by adding a new item (68.3) titled “Tattoo establishment” to the list of uses allowed by right. The new item shall read as follows:

(68.3) Tattoo establishment.

6. PART 12: TRANSIT ORIENTED DEVELOPMENT DISTRICTS

- a. Amend Section 9.1205, “Uses Permitted by Right” by adding a new item (22.5) titled “Tattoo establishment” to the list of uses allowed by right. The new item shall read as follows:

(22.5) Tattoo establishment.

A. CHAPTER 12: DEVELOPMENT STANDARDS OF GENERAL APPLICABILITY

1. PART 5: SPECIAL REQUIREMENTS FOR CERTAIN USES

- a. Add a new section 12.545, titled, “Tattoo establishment” with prescribed conditions. The revised section shall read as follows:

**Section 12.545. Tattoo establishment**


Tattoo establishment located in the UMUD zoning district are subject to the

following prescribed conditions:

- (1) Clients or business related visitors shall be by appointment only, with appointments scheduled only between the hours of 8:00 a.m. to 8:00 p.m.
- (2) There shall be a separation distance between tattoo establishments of 400 feet. The distance shall be measured from the nearest point of the buildings.
- (3) All federal, state, and local regulations for tattoo establishment shall be met.

Section 2. That this ordinance shall become effective upon its adoption.
