AN ORDINANCE AMENDING APPENDIX A OF THE CITY CODE -ZONING ORDINANCE

ORDINANCE NO.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. Appendix A, "Zoning" of the Code of the City of Charlotte is hereby amended as follows:

- CHAPTER 9: GENERAL DISTRICTS A.
 - PART 1: TABLE OF USES AND HIERARCHY OF DISTRICTS 1.
 - Amend Table 9.101, "Table of Uses" by 1) adding adding "PC" in the MUDD a. column under the "stadiums, colisums (misspelled)" row listed under the "Institutional Uses" header; 2) correct the spelling of "coliseums" in the same row and 3) add "PC" under the UMUD heading for "stadiums, coliseums", as these uses are currently permitted under prescribed conditions in Section 9.903(6), but are not shown in the table with "PC". The revised and new entry shall read as follows:

2. PART 8.5: MIXED USE DEVELOPMENT DISTRICT

Amend Section 9.8503, "Mixed Use Development District; uses permitted under a. prescribed conditions" by adding "stadiums, coliseums, and arenas" as a new use, with prescribed conditions. The new listing shall be added in alphabetical order and shall read as follows:

Stadiums, coliseums and arenas, provided that primary access for the development site shall be provided from non-residential streets.
