Summary of issues discussed and changes made as a result of the meeting:

Mr. Fields opened the presentation with a description of the site and the proposed development as well as an overview of the rezoning process. It was explained that the application was not proposing to rezone the property but rather to substitute an auto service center in place of a branch bank previously approved for the site. The Petitioner presented building designs that had been submitted to the City as part of the rezoning plan. There was some discussion about the road improvements that would be installed but no real question about the proposed use or the design of the building.

A number of site plan modifications have been made to the site plan as a result of review comments from staff agencies and from the Steele Creek Residents Association but no changes have been made as a direct result of the community meeting. The Steele Creek Residents Association has endorsed the proposed site plan amendment.
