Subject: Community Meeting

Rezoning Petition 2014-067 filed by Aldersgate United Methodist Retirement Community, Inc. to rezone approximately 91.31 acres located on the south side of Shamrock Drive across from Glenville Ave and the east side of Eastway Dr. across from Dunlavin Way. The Petition is to allow an increase in development from 375 Independent residential units to 500 units, an increase of 150 dependent residential units from 150 beds to 300 beds, an increase of 16 memory care (Alzheimer's & dementia) beds from 45 to 61 beds, the addition of (5) Adult Care Home beds, (12) Hospice beds, Outpatient Dialysis (for up to 20) and up to 70,000 sq. ft. of additional resident amenity and service spaces. The Petition would also include relocation of the existing Environmental Services facility (offices, maintenance & grounds keeping). The Existing zoning classifications are R-17MF and INST(CD) and the proposed classifications are INST(CD) and INST(CD)(SPA).

We are assisting Aldersgate United Methodist Retirement Community, Inc. (the "Petitioner") in connection with a Rezoning Petition it has filed with the Charlotte-Mecklenburg Planning Commission seeking to rezone an approximately 91.31 acre site within the overall +-235 acre campus. The "Site" is located within the existing core Aldersgate campus on the south side of Shamrock Drive across from Glenville Ave and the east side of Eastway Dr. across from Dunlavin Way within property currently zoned INST(CD) [Conditional District] and R-MF17. The purpose of the rezoning is to permit expansion of the existing Senior programs at Aldersgate allowing for the development of additional independent residential apartment homes, single-family homes, assisted living apartments, a new Skilled Nursing Center, expansion of the existing Memory Care for Alzheimer's and dementia residents and expanded health and resident amenities. The proposed Rezoning would be to INST(CD) and INST(CD)SPA to match the previously rezoned portions of the Aldersgate campus.

In accordance with the requirements of the City of Charlotte Zoning Ordinance, the Petitioner will hold a Community Meeting prior to the Public Hearing on this Rezoning Petition for the purpose of discussing this rezoning proposal with nearby property owners and organizations. The Charlotte-Mecklenburg Planning Commission's records indicate that you are either a representative of a registered neighborhood organization or an owner of property that adjoins, is located across the street from, or is near the Site.

Accordingly, on behalf of the Petitioner, we give you notice that representatives of the Petitioner will hold a Community Meeting regarding this Rezoning Petition on June 26, 2014 (6:00 PM – 8:00 PM). ## COMMUNITY MEETING REPORT

Petitioner: Aldersgate United Methodist Retirement Community, Inc.

Rezoning Petition No. 2014-067

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

### **PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:**

A representative of the Petitioner, Agent; Frank S. Quattrocchi, Shook Kelley, mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing such notice in the U.S. mail on 6/13/2014. A copy of the written notice is attached hereto as Exhibit B.

### **DATE, TIME AND LOCATION OF MEETING:**

The Community Meeting was held on 6/26/2014 at 6:00 PM – 8:00 PM at The Aldersgate Fellowship Hall, 3800 Shamrock Drive. Charlotte, N.C. 28215.

### **PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):**

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit C. The Petitioner was represented at the Community Meeting by the Petitioner's Representatives; Suzanne Hodge Pugh, President/CEO, Tim Rogers, Director of Mission Advancement, Luke Short, CFO, Karen Aiken, Steve Scott, Environmental Services & Agent's representatives, Frank S. Quattrocchi and Faron Franks, Shook Kelley.

### **SUMMARY OF PRESENTATION/DISCUSSION:**

Per request of the Petitioner an informal Power Point Presentation was prepared for the meeting by the Agent and attached hereto in pdf format as Exhibit D. The Petitioner's and Agent's representatives welcomed the attendees and introduced the Project to the attendees as each arrived and gave a brief update on the goals and rationale for the Rezoning Petition. Four Stations were set up with large format site plans as illustrative representation for review by the attendees with the Petitioner's and Agent's available for questions and responses. The representatives explained that the Petitioner proposed to rezone an approximately 91.3 acre site, a portion of the existing 237 acre Aldersgate community, adjacent to Shamrock Drive from INST (CD) and R-MF-17 to the proposed zoning district, INST (CD) SPA as a continuation of the current pattern of rezoning within the core Aldersgate development. The representatives explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents, neighborhood leaders and property owners.

Suzanne Pugh and Tim Rogers provided background information concerning the Petitioner's process and experience as a non-profit CCRC (Continuing Care Retirement Community) and explained the typical operations of its facilities. The representatives reviewed the site plan and pointed out the various commitments made by the Petitioner emphasizing the areas that did not include any proposed changes. The rezoning submittal plans located at the four stations were used to explain the site's design concepts, proposed building components and proposed operations.

The following represent the comments and conversations between the Petitioner, Agent and neighborhood participants attending the meeting:

(Q) If the petition is approved, when would construction of the various projects begin.

(A) It was noted that the Aldersgate Board would vote to approve funding in Mid July and if approved the normal schematic, design development and construction document process would be followed with construction to begin in summer of 2015, pending state approvals of the licensed health components, Skilled Nursing and Memory Care.

- (Q) If the Skilled Nursing Facility is relocated to the proposed Petition area, what will happen with the existing Asbury Nursing Facility along Shamrock Drive?
- (A) Studies have been done that had proven the facility no longer functions well for today's market level of Senior Care. It has not yet been determined if the facility will be repurposed, if viable, or taken down to allow for future development.
- (Q) What is planned within the area that is currently open space and a small golf course backing up to the Windsor Park neighbors?
- (A) The area referred to within Petition Area B has no current plans for change from the 1999 Approved Zoning and that 39 of the 75 allowable existing cottages have been constructed, mostly between the 1950's and 1970's and that no new dwellings are planned at this time.
- (Q) Will the tree buffers remain along the existing southern edge of Area B and along the stream area on the eastern edge of the proposed Skilled Nursing site?
- (A) Residents with ownership along the shared property line within Area B were made aware that there would be no changes to the buffers and no proposed changes to the existing dwellings at this time.
- In general, many questions focused on where the proposed new buildings were to be constructed and once the neighbors understood that the initial phases and future phase were focused around the existing core campus at the central green space in front of Epworth Place 'Tower' and in the existing Environmental Services area, adjacent to the Methodist Home Park and Eastway Drive, they no longer had many specific questions about the proposed designs of the specific buildings. Most were concerned and relieved that new construction was not proposed close to their property lines that would affect their existing privacy or views into the natural areas within the Aldersgate property, which they enjoyed. Several attendees also noted that they appreciated and were in favor of the existing gated areas at dead end streets or future dedicated ROW areas shared between Windsor Park and the Aldersgate campus.
- Associated Discussion Items
- Many of the questions posed by the attendees did not directly relate to the Conditions of the Petition or associated acreage within the Petition area but related to portions of the Aldersgate community along Shamrock Drive including the potential sale of adjacent property or the path and process of admittance to Aldersgate as a potential resident.
- (Q) What will happen with the multi-story Liberty Tower along Shamrock Drive?
- (A) The Liberty property currently is not owned by Aldersgate and was once the original Methodist Nursing Home. It was sold to Liberty and currently Aldersgate is in the process of assessing if they will purchase the facility back as Liberty has constructed two alternate facilities within the county and offered the building for sale. Aldersgate will most likely purchase but no plans are formulated at this time for future use or demolition.
- (Q) Several attendees requested marketing materials and questioned the process for admittance.
- (A) Staff of Aldersgate explained the process and options and advantages of becoming a member of the community.

### General Discussion Items

- The Petitioner and Agent discussed continuation of the residential apartment housing development pattern based on the existing core portions of Aldersgate with the new inclusion of the Skilled Nursing Facility.
- The Petitioner discussed the proposed Skilled Nursing Facility product to be constructed within the existing wooded area currently housing the Environmental Services facility and that all Skilled Care ‘Houses’ would have access to group courtyards in order to provide all residents with natural views and as a method to vary the exterior of the building’s elevations.
- The Petitioner discussed the proposed locations of the various components to be developed as part of the initial phases that included the independent living apartments, memory care addition, addition to Epworth Place common amenity areas and the layout of the Skilled Nursing Facility along with replacement and relocation of the Environmental Services.
- The Petitioner discussed the Aldersgate Community as a non-profit institution that attempts to give back to the community and particularly the Shamrock Corridor by providing/leasing land along the corridor to the following non-profit institutions at a minimal fee; Mecklenburg Parks & Recreation, The Charlotte History Museum/Hezekiah Alexander Home Site, Western United Methodist Conference Center, Alzheimer’s Association of the Carolinas and the Charlotte Senior Center
- The overall tone of the meeting comments were very positive and the attending residents and neighbors felt that the Aldersgate Community was beautifully maintained and a positive influence on the surrounding community and their property values.




# Shook Kelley IL/ Commons Expansion Master Planning Process- Concept Design








