**Petition Number: 2014-089 Parcel No. 071-016-02, 071-016-05, 071-016-12, 071-016-13 West 4<sup>th</sup> Street and Grandin Road**

COMMENTS: There are several street trees surrounding the project. These trees must be protected during all phases of construction by fencing. All underground utilities shall be placed outside of the trees' protected root zone or be bored under the roots. The protected root zone extends 6 inches for every 1 inch of tree diameter with a minimum of 3 foot circumference for the smallest tree. The revised plans do not reflect the agreed to driveway location on the W. 4<sup>th</sup>. This meeting was conducted on-site September 16, 2014. **Petition Number: 2014-095 Parcel No. 029- 052-13 – N. Tryon Street (NC 29) and Salome Church Road**

COMMENTS: Trees in the right of way of N Tryon St., West Pavilion Boulevard, and Salome Church Rd. are protected by the Tree Ordinance. No trees can be removed from or planted in the Right of Way of N. Tryon St. or Salome Church Rd. without permission of NC Department of Transportation and the City Arborist's office. The petitioner must submit a tree survey for all trees 2" or larger located in these rights of way of these three streets. In addition, the survey shall include all trees 8" or larger in the setback of all three roads.



**Petition Number: 2014-096 Parcel No. 229-051-35 Audrey Kell Road**

COMMENTS: Trees in the right of way of Audrey Kell Rd. are protected by the Tree Ordinance. No trees can be removed from or planted in the Right of Way without permission of NC Department of Transportation and the City Arborist's office. The petitioner must submit a tree survey for all trees 2" or larger located in the right of way. In addition, the survey shall include all trees 8" or larger in the setback.

**Petition Number: 2014-100 Parcel No. 083-021-01 Matheson Avenue.**

COMMENTS: Trees in the right of way of Matheson Avenue are protected by the Tree Ordinance. No trees can be removed from or planted in the Right of Way without permission of the City Arborist's office. The petitioner must submit a tree survey for all trees 2" or larger located in the right of way. In addition, the survey shall include all trees 8" or larger in the setback.
