COMMUNITY MEETING REPORT Petitioner: The Salvation Army, a Georgia Corporation Rezoning Petition No. 2015-010

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing such notice in the U.S. mail on 11/20/2014 & 11/21/2014. A copy of the written notice is attached hereto as Exhibit B.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Tuesday December 2, 2014 at 6:00 pm at The Center of Hope Women's and Children's Shelter, 534 Spratt St., Charlotte, NC 28206 in the chapel/meeting room.

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as <u>Exhibit C</u>. The Petitioner was represented at the Community Meeting by Major Bobby Lancaster, Deronda Metz, Renee' Kilgo, Carrie Gault, Lynne Feretti and Alyssa Cehok.

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's agent, Major Bobby Lancaster, welcomed the attendees and introduced the Petitioner's team. Major Lancaster indicated that The Salvation Army is proposing to rezone this building from a current 0-6CD zoning to a MUDD-O zoning.

Carrie Gault, Architect with Happy Box Architecture, PLLC explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the rezoning site plan and respond to questions and concerns from nearby residents and property owners. She explained that the original site plans in 1991 stated that it this building was zoned at 38,000 square footage and by doing this renovation it is adding approximately 4800 more feet to that number; therefore the City if Charlotte Planning Department is requesting that we rezone to a MUDD-O. It was stressed that the building structure square footage is not changing.

Ms. Gault also provided the rezoning site plan and pointed out that there is NO construction or additional buildings being added — just a renovation of the third floor that currently exists as an empty room. Changes will be done to add 64 more beds for homeless women and children. Renderings and drawings were available for review to show the proposed changes. Lynne Feretti of Tyler 2 Construction stated that Tyler 2 is the contractor doing the job.

12/2/2014 - Minutes from Community Meeting for Rezoning

<u>Welcome</u> – Major Lancaster introduces himself and states he is the Area Commander for The Salvation Army of Greater Charlotte; he reminds the guest that if they did not sign in at the door to please make sure they sign the attendance sheet before they leave. We MUST have this.

<u>Introductions of Petitioners Guest:</u> Lynne Feretti and Alyssa Cehok with Tyler 2 Construction, Carrie Gault with Happy Box Architecture, Deronda Metz – COH Director and Renee Kilgo – staff.

Major Lancaster asks the notified guest (only one) to introduce herself – her name is Lucille Smith and she is with Greenville Urban Community and her address is 1217 Fontana Ave., Charlotte.

Major Lancaster turns the meeting over to Carrie Gault whom addresses the Purpose of this community meeting: is to notify you - our neighbors - that we have applied to The City of Charlotte to re-zone our property here from the current 0-6CD zoning to a MUDD-O classification. This request was directed by the Planning Department with the City of Charlotte. They are requesting that we do this due to a renovation project we are doing. It will not change the physical building in any way; there is no construction additions being done – just a renovation job of the third floor that exists to make it a dorm living area.

Deronda Metz (Center of Hope Director) – she speaks about the project itself and the renovation that this will add 64 more beds for women and children. Guest Lucille Smith asks how many beds are there currently. Ms. Metz states 250 and that with the addition there will be a total of 314 beds.

Ms. Smith states that she was once in a homeless shelter and tells her story of how she succeeded and got on her feet. She is familiar with our shelter and she thinks this is a good thing and thanks us for the programs and assistance we are providing to women and children here in Charlotte. States she is familiar with rezoning issues.

Major Lancaster asks Ms. Smith if she has any more questions. She states no. At this point meeting is adjourned.

Major Lancaster thanks everyone for coming.
