COMMUNITY MEETING REPORT
Petitioner: Meeting Street
Homes & Communities
Rezoning Petition No. 2015-013

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing such notice in the U.S. mail on (1/17/15). A copy of the written notice is attached hereto as Exhibit B.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Monday 1/26/15 at 6:00-8:00PM at Tom Sykes Recreation Center @ Dilworth Elementary School 1501 Euclid Avenue Charlotte, NC 28203

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit C. The Petitioner was represented at the Community Meeting by (Joe Roy and Abe Lehman, Meeting Street Homes, Teresa Hawkins, Landscape Architect, John Burgess and Pat Campbell, John Burgess Design). A Meeting Agenda was handed to all attendees (See Exhibit D).

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's agent, Teresa Hawkins, welcomed the attendees and introduced the Petitioner's team. Teresa Hawkins indicated that the Petitioner proposed to rezone an approximate .4188 acre site (or 18,240 square feet) located at 1620 and 1624 Kenilworth Avenue from R-22MF to MUDD (CD)/Conditional Mixed Use District, further identified as Tax Parcel #'s 123-127-20, 123-127-21, and 123-127-98. Teresa Hawkins then explained the rezoning process in general and outlined the critical meeting dates associated with the remainder of the rezoning process. She also stated that the purpose of this meeting was to discuss the rezoning request and the revised conditional site plan and architectural elevations and to respond to questions and concerns from nearby residents and property owners.

Joe Roy with Meeting Street Homes and Communities provided background information about the Petitioner's experience with the development of townhome communities. Teresa Hawkins then presented the site plan and pointed out various commitments made by the Petitioner and summarized the changes that had also been made to the originally filed rezoning site plan, per previous meetings with the DCA Land Use Committee and the adjacent neighbors. John Burgess and Pat Campbell, the architects for this project, showed proposed architectural elevations and discussed the design of the proposed townhome development and changes and additions made to these elevations per input from the DCA and adjacent property owners. They used the elevations and renderings to explain the townhome design concepts and operations.

The following issues were then discussed by the attendees in response to the presentation outline above. These issues included the following:

- Discussion ensued about the location of the proposed bus stop on Kenilworth. It was clarified that the Petitioner will have to work with both CATS and CDOT for the exact location of the bus stop pad but that the Petitioner will be responsible for constructing this pad to CATS standards as their expense.
- Attendees expressed concern over the location and storage of the garbage and recycle bins on the days where the City picks up curbside on Kenilworth Avenue. The Petitioner clarified that the HOA documents would require that the garbage and recycle bins be stored in the unit's garages but that there was little that could be done about the storage of the units along the curb on Kenilworth Avenue, as the planting strip where these units will sit for pick up are within the City right of way. The Petitioner agreed to work with the City (CDOT, Planning and Solid Waste) to come up with a more aesthetic way for these units to be stored on garbage pick- up days, but reminded everyone that this is really a City issue to allow encroachment within the public right of way. Mr. Sridhar Narhari, the adjacent property owner, expressed that he did not want an on- site garbage dumpster as part of this project.
- Attendees expressed that a solid cedar fence would be preferable to one with planting gaps along the common property line with the existing residence owned by Sridhar Narhari. The Petitioner agreed to construct a solid cedar fence to replace the existing fence, in the same location, along the common property line the Mr. Narhari's residence.
- Attendees expressed concern that the proposed one way driveway serving the units was too narrow and had turning radius issues that would not work with the planted areas that are proposed by each parking pad. Teresa agreed to superimpose AASHTO turning radius for a passenger vehicle onto the site plan to see if there is adequate turning radius at each garage/parking pad. There was also concern expressed that the one way 12 foot wide driveway would not allow 2 cars to pass. Pat Campbell noted that he lives in a condo across from Dilworth Elementary and that his parking lot, which is shared by several condo units, is served by a one way drive and that is the case for many attached and multi- family housing developments within the Dilworth community.
- Attendees expressed concern over the note that Planning staff asked to be added to the front setback area adjacent to Kenilworth that states that a courtyards, bike rack, benches, tables, aesthetic landscaping and art be added to this area. Petitioner will express the attendees concerns regarding this note back to Planning staff. There was consensus that there was not enough room for all of these items. It was duly noted that Planning staff regarded this as a general note and did not mean that all of these items would be squeezed into the setback area. Nevertheless, the Petitioner will revise this note.
- John Fryday, with the DCA Land Use Committee, expressed concern that the Petitioner was not willing to submit all of the architectural plans and elevations that were part of the community meeting power point presentation as part of the conditional rezoning package. The Petitioner is concerned that if he did submit this much detail, that he wouldn't be able to make minor changes to his elevations as he moved into the preparation of construction documents. Mr. Roy, the Petitioner, did however commit that, with very minor changes, the concept depicted in the power point was very close to what will be constructed.
- An attendee requested that the siding proposed for the units be cedar shakes and not hardiboard planks. The Petitioner clarified that the siding would not be hardiboard and that brick has been added to the elevations.
- Attendees expressed concern as to how this project would design a solution to the storm water drainage problem that originates from the Harris Teeter development. This storm water flows from the Harris Teeter property down a wood retaining wall and down the alley behind the homes fronting on Kenilworth Avenue. Joe Roy indicated that Tom Ferguson, the City Engineer, had contacted our civil engineer to discuss the need to Harris Teeter to formulate a design and construct a solution to this problem. Linda Coad, who has worked with the City and Harris Teeter, indicated that Harris Teeter had proposed a concrete vault in one design alternative, but they never followed

through to construct it. Ms. Coad also indicated that the easements from the affected property owners were in place at one time to accommodate Harris Teeter's (i.e. Edens and Avant's) storm water solution. The Petitioner committed that the proposed townhome project will adhere to the City Storm water regulations as part of the development of construction documents for the project. A note to this affect has already been added to the conditional rezoning site plan.

- Joe Roy, the Petitioner indicated that he planned to meet with Edens and Avant, the owner of the Harris Teeter property on 1/27/15 in order to ask them to provide an easement for a sidewalk connection from the townhome property onto the Harris Teeter property. He indicated that he would also talk to the E&A representative about the storm water issue.
- Attendees expressed concern regarding the number of townhome units (9) and were concerned that due to the 9 units there was not enough open space proposed for this project. They indicated that 9 units were too many for this site and that they would prefer to have less but larger units that would allow for large maturing trees in the front and the back of the townhome building.
- There was also concern over the sell price for these units (\$350,000 range) and questions about why these units couldn't be larger and priced for a higher sell price (i.e they want a higher end product, and they pointed to an example of condominiums recently built behind the vacant lot across East Blvd from 131 Main between Scott and Kenilworth Avenues. The Petitioner indicated that he had misquoted their performa and that the actual sales price per unit will be in the \$400,000 plus range (or \$250/square foot).
- Linda Coad, who lives two doors down Kenilworth Avenue, expressed concern that the rear of the town home building did not have a front door appearance. She suggested that a door and a courtyard be added beside the garage door in order to provide access directly into the garage space.
- Concern was expressed over the lack of parking for each unit and there was concern among the attendees that guests (and perhaps residents) would end up parking in the parking lot of the adjacent Kenilworth Commons and the Harris Teeter parking lot. The Petitioner indicated that they could prohibit such parking via the HOA documents.
- Concern was also expressed over a public sidewalk, connection from Kenilworth Avenue to the Harris Teeter parking lot, as this sidewalk will pass by the private courtyards associated with each townhome unit.
- There was a general concern that this project would cause adjacent residential homes to lose value, although the Petitioner pointed out that this would not be the case. Recent research in the Mecklenburg County tax records do not indicate a loss of value to residential home in the Dilworth Community after an adjacent attached or multi-family project is constructed.
