Be sure to check with Urban Forestry in Land Development in case there are tree save and/or planting requirements on private property.

COMMENTS: Street tree in the street right of way along West Boulevard must be protected during all phases of construction by fencing. All underground utilities shall be placed outside of the trees' protected root zone or be bored under the roots. The protected root zone extends 6 inches for every 1 inch of tree diameter including private property. Contact Donald McSween (704-336-3459) at the City Arborist's office for a permit if you plan to plant in the right of way. Street tree species must be approved before planting.
