DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Monday June 1st at 6pm at Sugar Creek Recreation Center, 943 West Sugar Creek rd, Charlotte, NC 28269

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit C. The Petitioner, Bukola Olasimbo was present at the Community Meeting along with her representative Harold Jordan.

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner, Ms. Bukola Olasimbo welcomed attendees and introduced her agent, Mr. Harold Jordan to attendees.

Mr. Jordan displayed the conditional site plan and explained the rezoning request that the meeting was scheduled for. He noted that the 40 kids in the site plan was in anticipation of the maximum future growth for the child care center and that Ms. Olasimbo was looking to start with less than 30 kids.

An attendee, Ms. Sylvia Cannon, mentioned her concern for the flow of traffic between Sugar Creek rd and Derita Avenue and would like for that to be addressed to mitigate cut-through traffic through the adjoining neighbood. She also asked what the contingency plan was for if the child care center failed to retain as many kids as were needed to stay profitable. She said the neighborhood would not want to have an abandoned property on their hands.

The petitioner, Ms. Olasimbo spoke to her professional background as a banker and explained how she had found a need for setting up a daycare that would open its doors to provide quality care to all children especially those with special needs on account of her first-hand experience of challenges she faced in finding child care for her 7 year old boy with special needs. She also mentioned that the day care center will have staggered drops-off and pick-ups and that van transportation will also be provided.
