COMMUNITY MEETING REPORT

Petitioner: Lat Purser & AssociatesRezoning Petition No. 2015-053

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on <u>Exhibit A</u> attached hereto by depositing such notice in the U.S. mail on March 24, 2015. A copy of the written notice is attached hereto as <u>Exhibit B</u>.

A copy of the written notice ("Exhibit B") along with a personal message informing of the Community Meeting was also sent via email to the following individuals set out on Exhibit D in addition to the physical letters.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on April 14, 2015 at 6:30 PM at 4530 Park Road, Suite 300 in the Large Conference Room.

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as <u>Exhibit C</u>. The Petitioner was represented at the Community Meeting by Lat H. Purser and Casey Gebhardt of Lat Purser & Associates, Inc.

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's agent, Lat H. Purser, welcomed the attendees and introduced the Petitioner's team. Lat H. Purser indicated that the Petitioner proposed to rezone an approximately .385 acre site located at 4500 Park Road from the current zoning of O-2 to MUDD-CD. Lat H Purser explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

Lat H. Purser provided background information about the Petitioner's experience and the typical operation of its facilities. He then presented the site plan and pointed out various commitments made by the Petitioner. He then showed the proposed architectural elevations and discussed the design of the proposed facility. He used the elevations and renderings to explain the facility's design concepts, and operations.

Once the attendees were briefed and summarized of the rezoning, site plans and building layout, we opened the floor for any questions, comments or concerns regarding our plans. Mike Fleming spoke out and introduced himself, he then asked general questions about the property such as, how will this project impact traffic flow on Montford Drive, what is the time frame regarding construction and what is the proposed use of the building. Lat Purser, explained that there will be a connection with the neighboring parking lot for additional parking and through traffic access to the stop light, thus negating

all, if any parking concerns along Montford Drive. He also explained to Mike what the projected timeline of the project was as well as informing him of the planned use for the site. Overall Mike was pleased with the layout and look of the elevations, he said he didn't have any concerns regarding the rezoning and said that the site plan looked great.

Please note that the petitioner, Lat H. Purser has been in constant contact with the Madison Park Home Owners association President, Douglas Welton. Douglas invited Lat H. Purser and Casey Gebhardt to their monthly Home Owners Association meeting on April 13, 2015 which was the night prior to the community meeting. At this meeting, Douglas allowed Lat Purser to stand up in front of the home owners, approximately 40 attendees, and inform the Madison Park residents about the rezoning and future plans for the site. Lat Purser also stayed after the meeting and allowed the home owners to take a closer look at the site plans and ask any questions. As a whole, the only immediate concern was how this project would impact traffic on Montford Drive, but once they were informed that the site would have direct access to the 4530 Park Road parking lot all concerns were dismissed. Numerous home owners mentioned that they had planned to attend the community meeting, but upon hearing the presentation and seeing site plans most questions or concerns had already been answered.

The petitioner, Lat H. Purser has also been in constant contact with the adjoining property owner, Chris Mottram. Please note that Chris was not able to attend the community meeting due to a personal obligation. However, Lat H. Purser was able to meet Chris on site on Friday, April 17, 2015 to discuss the rezoning. During the meeting Chris expressed concern about light and noise, Lat H. Purser showed him site plans and talked him through what the future vision of the property is. As of today, Lat H. Purser and Chris Mottram are still in ongoing discussions to properly address his concerns.


