COMMUNITY MEETING REPORT PETITIONER:

REZONING PETITION NO.: 2017-186

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on <u>Exhibit A</u> attached hereto by depositing such notice in the U.S. mail on January 19, 2018. A copy of the written notice is attached hereto as <u>Exhibit B</u>.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on February 1, 2017 at 6:00 pm. at the Wilmore Community Center, 501 West Blvd., Charlotte NC 28203.

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as <u>Exhibit C</u>. The Petitioner was represented at the Community Meeting by Bobby Drakeford, Russell Fergusson, and Nick Bushon.

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's agent, Russell Fergusson, welcomed the attendees and introduced himself, Bobby Drakeford, and Nick Bushon. Petitioner presented the proposal to rezone seeking to rezone the approximate 0.87 acres site (the "Site") located at 224, 228, 232, and 236 W. Kingston from the R-22 MF zoning district to UR-2 (CD) (original rezoning petition called for Transit Supportive Overlay, but is no longer applicable) zoning district. The agent explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners. The meeting was very well attended.

Mr. Fergusson, Bobby Drakeford and Nick Bushon presented the site plan and explained the basic elements of the proposed development, including the efforts to move forward with plans that will meet HDC requirements for the area. Petitioner explained the basic and the standards and limits being incorporated into the revised Site Plan. The presentation referenced the adjacent commercial use and the vibrant and growing commercial uses on South Tryon and the need for "missing middle" options for the residential market in the area. Petitioner explained some of the thoughts that led to the proposed plan and the effort to avoid undue interference with the existing adjacent residential structures. Discussion of the existing buildings on the subject parcel included a discussion of the problems and associated blight with past uses and vacancy. Petitioner also explained the fact that these parcels abut a commercial use, and the proximity to S. Tryon, as reasons why the proposed density is appropriate. Discussion was had regarding the value created by the additional units which may serve to protect the single-family residential neighborhood from further encroachment and the impacts of the intensifying commercial uses by preventing a large parcel from being combined at the corner of W. Kingston And S. Tryon.

The presentation quickly morphed into a question and answer session. Matters regarding the general understanding of the area plan were discussed. The attendees discussed the general purpose of the rezoning, the architectural concepts at this time and the requirements of the Historic District. Petitioner answered community questions regarding the setbacks, the heights of the building, the location of garages, the retention of the large planting area and sidewalk to match existing and neighboring properties, the parking plans, the proposed density, incorporation of community design and whether or not the current city sewer plans could delay the project. Petitioner explained the answers to all of the factual questions and the community members engaged in discussion including suggesting the possibility of addressing the alleyway. The general consensus towards the proposal was positive and that this would be a significant improvement over the existing status of the property.

Petitioner explained its understanding that the HDC process would be a separate process and that confirmation of final design details would be determined in the HDC process.

Included in attendance were approximately twenty area residents including several people that live on the same block as the rezoning.


