COMMUNITY MEETING REPORT FOR REZONING PETITION NO. 2018-014

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Department pursuant to Section 6.203 of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATES AND EXPLANATIONS OF HOW CONTACTED:

The required Community Meeting was held on Wednesday, February 28th, 2018. A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on <u>Exhibit A</u> by depositing the Community Meeting Notice in the U.S. mail on 2/16/18. A copy of the written notice is attached as <u>Exhibit B</u>.

TIME AND LOCATION OF MEETING:

The Community Meeting required by the Ordinance was held on Wednesday, February 28th at 7:00 PM, at Charlotte Banquet Center, 9009 Bryant Farms Rd, Charlotte, NC 28277.

PERSONS IN ATTENDANCE AT MEETING:

The sign-in sheet from the required Community Meeting is attached as <u>**Exhibit C**</u>. The Petitioner's representative at the required Community Meeting were Matt Stiene, Andy Mauler and Lauren Dalton with Novant Health, Phillip Hobbs with Alfred Benesch & Company, and Randy Goddard with DRG. Also in attendance was Keith MacVean with Moore & Van Allen, PLLC.

SUMMARY OF ISSUES DISCUSSED AT MEETING:

I. <u>Overview of Petitioner's Presentation.</u>

Introduction and Overview of Development Plan.

Keith MacVean opened the meeting and welcomed everyone in attendance. He then introduced Matt Stiene, Andy Mauler and Lauren Dalton with Novant Health, Phillip Hobbs with Alfred Benesch & Company, and Randy Goddard with DRG.

Mr. MacVean gave an overview of the site plan and the existing zoning. He then reviewed the site location on the existing church property. He then explained what the current zoning allows and that a portion of the current site that zoned for only religious uses. The site is being rezoned in order to allow medical uses, including a 50 bed hospital.

Matt Stiene explained Novant's vision for the site with attendees. Novant Health wants to bring healthcare access to neighborhood communities. They propose a 50 bed hospital unit with office space including a small family practice. They plan to provide a neighborhood healthcare campus with access points from Highway 521 as well as Marvin Road and Providence Road West.

Phillip Hobbs then reviewed the site plan and explained that the development will include 2 new public roads including the extension to Ballancroft Parkway through the site.

Mr. MacVean went on to explain the improved sidewalk networks along Highway 521 and the addition of on-street parallel parking along Marvin Road. He then reviewed key dates in the rezoning process.

Mr. Stiene reviewed the conceptual renderings with the audience and showed examples of potential building arrangements. The development is likely to begin in Phases with the family practice being constructed first.

The meeting was then opened to questions.

II. <u>Summary of Questions/Comments and Responses:</u>

Attendees asked about access to the campus and potential traffic. There will be entrances from Marvin Road, Highway 521 and the newly extended Ballancroft Parkway. There is a traffic study underway associated with the access to Highway 521, and the Petitioner is working with the City and State to determine the best traffic solutions. Mr. Goddard elaborated that there will be left and right turn lane access from Highway 521. Attendees also asked if an emergency signal would be in place. There will not be a designated signal for emergency use.

One attendee asked why there were so few beds for the hospital. Matt Stiene explained that this campus is being developed as a facility for community based care. It was then asked if there will be a helipad. This medical campus will have an emergency department and include a required helipad.

The neighboring property owner asked how the Petitioner plans to mitigate noise for his hotel guests. Mr. Stiene explained that Novant currently has 11 community hospitals and the emergency department is not a continuous stream of noise. Novant Health strives to be a good neighbor in the community.

One attendee asked how many people would be employed on this campus. There could be anywhere from 300-500 employees on site depending on the services offered.

Attendees then asked about the campus amenities and plantings. The development will follow the Tree Ordinance and offer street trees as well as planting strips. The campus is proposed to be pedestrian friendly and offer green spaces to potentially connect to the shopping center.

One attendee asked if the development planned to have connectivity to the church. At this time, there is no plan to connect with the church.

Attendees then asked about the construction of the site and the location of the retention pond. The location of the pond is not set but will potentially be buried and sand filtered instead. Although the building will most likely not be LEAD Certified, Novant is always working on their energy consumption and all buildings will meet the Energy Star requirements.

Keith MacVean thanked everyone in attendance and the meeting was adjourned.
