COMMUNITY MEETING REPORT Petitioner: Ricardo Torres Rezoning Petition No. 2018-019

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

<u>PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW</u> <u>CONTACTED:</u>

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing such notice in the U.S. mail on March 16^{th} , 2018. A copy of the written notice is attached hereto as Exhibit B.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Wednesday April 4th, 2018 at 6pm at 4918 Central Av. Charlotte, NC 28205.

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as <u>Exhibit C.</u> The Petitioner was represented at the Community Meeting by Ms. Lucia Griffith and also attending was Nancy Perez.

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's agent, Ms. Lucia Griffith, welcomed the attendees and introduced the Petitioner's team. Ms. Griffith indicated that the Petitioner is proposing to rezone an approximately 0.42 acre site (the "Site") located at 3450 North Sharon Amity Road, Charlotte, NC 28205, from the CD-O1 zoning district to CD-O1 zoning district. Ms. Griffith explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

Ms. Griffith then presented the site plan and pointed out various commitments made by the Petitioner. Ms. Griffith also showed a proposed building design concept for general information.

Ms. Bobbi Almond, representing the Wilora Lake/ Verndale Glen Neighborhood Association, asked why would the sidewalk be relocated and how would it connect to the existing adjacent sidewalk. Ms. Griffith explained that the sidewalk would be relocated due to the City's request of a 16' planting strip and the Petitioner will comply building a new sidewalk as requested by the City. She also explained that the new sidewalk on the Site will connect on both sides of the property to the adjacent sidewalk. Ms. Almond also expressed her concern on the road's heavy traffic and asked about the Petitioner's commitment to build the project. Ms. Griffith explained that the Petitioner is fully committed to build the project upon securing a building permit after approval of the rezoning request. Regarding the traffic concern, Ms. Griffith mentioned that due to the size of the project the traffic increase will be minimum and that the Charlotte Department of Transportation will be reviewing this project for traffic increase.


