COMMUNITY MEETING REPORT

Petitioner: JV Transport, Inc. Rezoning Petition No. 2018-030

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on <u>Exhibit A</u> attached hereto by depositing such notice in the U.S. mail on 03/19/2018. A copy of the written notice is attached hereto as <u>Exhibit B</u>.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on March 29, 2018 at 6:00 Pm at the Friendship Missionary Baptist Church, located in 3400 Beatties Ford Rd. Charlotte, NC 28216.

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit C. The Petitioner was represented at the Community Meeting by Jose Contreras, owner of JV Transport, Hoover Gutierrez, Petitioner Real Estate agent and Ty Chapman, current owners Real Estate agent.

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's agent, Hoover Gutierrez, welcomed the attendees and introduced the Petitioner's team. Mr. Gutierrez indicated that the Petitioner proposed to rezone an approximately 2.75 acres located on the east side of Northpointe Industrial Blvd. site from the I-1 zoning district to I-2 (CD) zoning district. The agent explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

Hoover Gutierrez provided background information about the Petitioner's experience and the typical operation of its facilities.

The meeting began at 6:00 PM as scheduled. There were approximately 10 or so attendees to start the meeting and more came in as the meeting progressed. The owner's agent Ty Chapman began by explaining the overall planned use for the property and the layout of the site plan. I then introduced the Petitioner and gave a brief description of his business and overall plans with the property for the first 10 minutes of the meeting. This was met with questions and objections from the attendees. Several of the homeowners read prepared statements and made their points against the rezoning for approximately 40 minutes. The attendees asked the why the petitioner had chose this particular site for his trucking company and he explained it was a convenient location and based on the surrounding businesses and current uses that it would be a good place to park his vehicles. The attendees had concerns about the amount of traffic, times and frequency that the trucks would be coming in. We explained that he has only 5 trucks of and they are on designated routes, leaving Monday mornings and returning on Friday mornings to afternoon baring something out of the ordinary. There was also concern about warehousing and loading of trucks and it was explained that this is not going to be a warehousing facility. This lot will be strictly used for a dispatching/administrative office and parking spots for his vehicles. The attendees voiced their frustrations with the city, concerns and opposition to the rezoning and project all together. We thanked them for coming in we passed out our contact information and welcomed any questions. All the attendees left by 6:55 pm and the meeting ended promptly at 7:00 PM.
