Charlotte, NC	<b>Nightclub:</b> Any commercial establishment serving alcoholic beverages and providing entertainment for patrons including bars, lounges, and cabarets.
Austin, TX	<b>Cocktail lounge:</b> use of a site for retail sale of alcoholic beverages for consumption on the premises, including taverns, bars, and similar uses, except for restaurants.
Baltimore, MD	<b>Tavern:</b> A business establishment that: (1) is devoted primarily to serving alcoholic beverages to the public for on premises consumption; and (2) might or might not also: (i) serve food; and (ii) sell alcoholic beverages for off-premises consumption.
Boston. MA	<b>Bar:</b> An establishment devoted primarily to the retailing and on- premises drinking of alcoholic beverages. Such establishment may or may not serve food, and may or may not include dancing or entertainment.
Chicago, IL	<b>Tavern:</b> An establishment that is primarily engaged in serving alcoholic liquor for consumption on the premises and in which the serving of prepared food, live entertainment and dancing are permitted.
Cincinnati, OH	<b>Drinking Establishments:</b> Bars, nightclubs, lounges or dance halls serving beverages for consumption on the premises as a primary use and including on-site service of alcohol, including beer, wine and mixed drinks.
Columbia SC	<b>Drinking place</b> : An establishment engaged in the retail sale of drinks, such as beer, ale or wine for consumption on the premises.
Huntersville, NC	<b>Nightclub:</b> Any commercial establishment serving alcoholic beverages and/or providing entertainment for patrons, including bars, lounges, taverns, cabarets, and similar establishments.
Nashville/Davidson County Metro , TN	After hours establishment: Any establishment open to the general public at any time between the hours of 3:00 a.m. and 6:00 a.m., which has for its primary purpose entertainment, teen clubs, dance clubs, and establishments which feature the playing of live or recorded music. If the establishment requires a cover charge upon entry, contains a dance floor, or uses either a disc jockey or a live band, it shall be considered an 'after hours establishment,' regardless of whether the establishment serves or sells prepared food for consumption.
Philadelphia, PA	<b>Nightclubs and Private Clubs:</b> An establishment where 50 or more people regularly congregate primarily for entertainment purposes in the form of dancing or live or recorded music. The establishment may serve food or beverages to patrons for on- or off-premise consumption or may have one or more temporary or permanent area(s) set aside for the purpose of dancing by the patrons of the establishment. Such establishments may include, but are not limited to, discotheques, cabarets, private clubs,

	banquet halls, and similar places of assembly.
Seattle, WA	<b>Drinking establishment:</b> means an establishment other than a restaurant, licensed to sell alcoholic beverages for consumption on premises; that limits patronage to adults of legal age for the consumption of alcohol; and in which limited food service may be accessory to the service of alcoholic beverages. Drinking establishments may include but are not limited to taverns, saloons, brewpubs, bars, pubs, or cocktail lounges associated with restaurants.
Washington, D.C.	<b>Cabaret</b> : a restaurant or nightclub providing as the main focus of its business, programs of live entertainment such as singing, dancing, comedy, literary readings, or performance art. In a cabaret, the clientele generally sit at tables in order to watch the entertainment and are attended by waiters or waitresses who serve food or drink. Typically, there may be more than one show in an evening and a complete turnover in patrons.
