COMMUNITY MEETING: Charlotte Truck Rental Petition 05-107

Date of original contact: November 18, 2005

Persons contacted and explanation of how contacted: Meeting invitees were contacted by first class mail. (See attached letter and mailing list).

Date, time and location of meeting: The meeting was scheduled for 7:00 PM on December 5, 2005 at the offices of Charlotte Truck Rental located at 3009 Rozzelles Ferry Road.

Summary of discussion/issues discussed and changes to the petition as a result of the meeting: The discussion began with a brief overview of the rezoning process and a description of the site plan. The planned use remains the same; Charlotte Truck Rental presently occupies the site. No new buildings are planned for the property, but the zoning change will enable the sale of trucks on the site. Already, the current zoning permits the repair and rental of trucks. As was explained, the frontage area of the site was actually being downzoned from I-2 to I-1(CD). Thus, a wide assortment of heavy industrial and manufacturing uses, which are currently permitted by the I-2 zoning, would be removed as allowable uses. Other areas of the site were not being rezoned, specifically a rear portion next to Clyde Drive. That area is a legal nonconforming industrial area, but will receive new screening and landscaping as part of the proposal.

Discussion points were as follows:

- . improvements to the area per the City's plans for Rozzelles Ferry Rd
- . maintenance of the bus stop nearby
- . new lighting (none) planned for the site
- . what were the size(s) of trucks planned to be sold?
- . any zoning change at the rear along Clyde Drive?
- . describe the landscaping/screening improvements at the rear along Clyde Drive
- . will any jobs be available?
- . will there be any extra building space that might be available for rent for other uses?

Changes to the site plan resulted from comments received from staff.


