

Dear Neighbor,

A community meeting is being held at 6:00pm on Wednesday, April 5, 2006 at 7023 Beatties Ford Road. The purpose of this meeting is to present the proposed plan for rezoning the property from R-3 to INST (CD). The owner of this property plans to maintain the existing residence structure but change the number of children capacity from 12 to 21. It will require one additional parking space in the back yard area.

This is Phase I of three phases of total development for the existing daycare. When Phase I is full of children and there is a demand for more care, Phase II will be implemented. This will entail an addition of approximately 2,600 square feet that will provide for forty-seven (47) more children. When Phase II is filled and the demand of the community is for more care, Phase III will be developed. This addition will be approximately 3,300 square feet in size. This will provide for an additional +/- 52 children. This may take up to 5 or 10 years, depending entirely on the need for care of the children.

You are being notified of this meeting because your property is within 300 feet of the site. If you have any questions on this matter, it is our intent to answer them at the community meeting. We hope to see you there.
