
COMMUNITY MEETING FORM PETITION NUMBER 2007-34 SIMONINI BUILDERS

The topics discussed at the meeting included building placement, driveway location, tree preservation and maintenance of common areas. The comments from the neighbors generally indicated that a Simonini development is viewed positively in this location but there was concern about the number of homes being proposed.
