The Charlotte-Mecklenburg Board of Education Community Meeting Report for Rezoning Petition # 2007-039 March 8, 2007

The Charlotte-Mecklenburg Board of Education held a Community Meeting on Tuesday, March 6, 2007 at 6:30 p.m. at Pawtuckett Elementary School, 8701 Moores Chapel Road, Charlotte, North Carolina 28214. The purpose of the Community Meeting was to discuss with surrounding property owners the proposed Belmeade Road Elementary School / Middle School project (Rezoning Petition # 2007-039) and to get public input/comments.

Each person and organization on the list was sent a notice letter via U.S. Mail. All notices were mailed on or before February 21, 2007.
