THESE DEVELOPMENT STANDARDS FORM A PART OF THE REZONING PLAN ASSOCIATED WITH THE REZONING PETITION FILED BY CENTER CITY CLIMATE CONTROLLED STORAGE LLC, EDGELINE RESIDENTIAL, LLC TO ACCOMMODATE THE REDEVELOPMENT OF THAT APPROXIMATELY 2.14 ACRE SITE BOUNDED BY DAVIDSON STREET TO THE SOUTH, 15TH STREET TO THE WEST, CALDWELL STREET TO THE NORTH AND 16TH STREET TO THE EAST AND WHICH IS MORE PARTICULARLY DEPICTED ON THE REZONING PLAN (THE "SITE")

DEVELOPMENT OF THE SITE WILL BE GOVERNED BY THE REZONING PLAN, THESE DEVELOPMENT STANDARDS AND THE APPLICABLE: PROVISIONS OF THE CITY OF CHARLOTTE ZONING ORDINANCE (THE "ORDINANCE"). AND/OR TO THE FOLLOWING USES:

- DRY CLEANING FACILITIES. (PICK-UP AND DROP-OFF ONLY) INDOOR RECREATION, SUCH AS SPAS AND YOGA STUDIOS.

 PROFESSIONAL BUSINESS AND GENERAL OFFICES SUCH AS BANKS, CLINICS, MEDICAL, DENTAL AND DOCTORS' OFFICES, VETERINARY USE/INDOOR PET SERVICES, GOVERNMENT OFFICES, POST OFFICES, OPTICIANS' OFFICES, AND SIMILAR USES, PROVIDED, HOWEVER, THAT VETERINARY CLINICS WITH OUTDOOR RUNS SHALL NOT BE PERMITTED. - THE MAXIMUM GROSS BUILDING AREA THAT MAY BE DEVOTED TO THE ABOVE DESCRIBED NON-RESIDENTIAL USES SHALL BE 20,000 SQUARE FEET. OUTDOOR PORCHES AND PATIOS AND OUTDOOR SEATING AND DINING AREAS SHALL NOT BE CONSIDERED TO BE A PART OF AND SHALL NOT BE COUNTED TOWARDS THE MAXIMUM GROSS BUILDING AREA FOR NON-RESIDENTIAL USES.






