

COMMUNITY MEETING REPORT  
Petitioner: Charlotte-Mecklenburg Housing Partnership, Inc.  
Rezoning Petition No. 2015-082

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner, Shook Kelley, mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing such notice in the U.S. mail on June 12, 2015. A copy of the written notice is attached hereto as Exhibit B.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on June 25, 2015 at 6:00 PM – 8:30 PM at the Statesville Road Baptist Church located at 4901 Statesville Road, Charlotte NC 28269-4326.

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit C. Keith MacVean with Moore & Van Allen, PLLC and members of The Charlotte-Mecklenburg Housing Partnership (CMHP) including Julie Porter, Jim Donaldson, Fred Dodson, Andrew Rosti and Liz Ward represented the Petitioner at the Community Meeting. Randy Goddard with the DRG Group presented Transportation issues and Frank Quattrocchi with Shook Kelley presented the site plan.

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's agent, Keith MacVean with Moore & Van Allen, PLLC welcomed the attendees and introduced the Petitioner's team. These included representatives from the Charlotte-Mecklenburg Housing Partnership, Shook Kelley and the DRG Group. Keith MacVean indicated that the Petitioner proposed to rezone an approximately 64.33 acre site located at 3100 Cochrane Drive, 4927 Statesville Road & 2621 Cindy Lane in Charlotte, NC. The Petition is to allow the sites to be developed with a residential based mixed-use community consisting of single-family and multi-family homes. The existing zoning is B-2 (CD) and R-4 and the proposed zoning will be UR-2 (CD).

Mr. MacVean explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

A visual slide presentation was introduced by Julie Porter with CMHP, and provided background information about the Petitioner's experience and the typical operation of its neighborhood developments and affordable facilities. The visual presentation was jointly conducted by the other members of CMHP along with the DRG Group and Shook Kelley who presented the site plan and pointed out various commitments made by the Petitioner. Frank Quattrocchi showed the proposed architectural character of the specific development areas and discussed the street design and intentions for development of the

proposed residential areas. The presentation team used the diagrams and previously constructed examples of CMHP's residential construction to explain the development's character, quality design concepts, and proposed operations.

General topics of interest or concern centered around existing and proposed transportation issues; existing shortfalls of the transportation and pedestrian network and how the proposed development might add to these issues or help remedy some of the problems. Location of the multi-family and senior developments areas were broad topics of interest to the group as related to traffic and location to adjacent existing single-family.

Detailed minutes of the conversation about the rezoning are provided below including questions, responses and potential additional commitments made by the petitioner:

Q: For the 55+ Senior Development area(s) what happens if children move in?

Q: Can there be restrictions to exclude children?

A: The proposed Age Restricted +110 rental apartments and cottages would be restricted to 55 years and up but NC Fair Housing will not allow restrictions on children. CMHP noted that residents would be evicted if convicted of any illegal activities or breaking of any covenants or their leases.

Q: Existing traffic patterns on Cindy Lane are a 'nightmare' (excessive speed, motorcycles)

Q: Many people try to walk along Cindy Lane. A sidewalk is needed and requested.

A: CMHP & DRG proposed that a concerned neighborhood group could approach CDOT to investigate if the speed limit could be reduced. CMHP noted they would try to work with the City as part of the CNIP program to see if the City would fund continuation of sidewalk along Cindy Lane from the Petitioner's property to Murray Ave.

Q: What is the construction currently in progress along Cindy Lane and does it have anything to do with this Petition (2015-082)?

A: CMHP noted that construction at this time was not related to their Petition. Piedmont Natural Gas is conducting the work for installation of new/extended gas service, not related to the proposed development.

Q: Cochrane Drive to Statesville Avenue north is currently an issue and requires a traffic signal due to existing traffic patterns. Lane needs additional storage capacity for left turns.

Q: The addition of 100 plus multi-family apartments on Cochrane Drive will exacerbate this congestion.

A: Randy Goddard with DRG noted that per CDOT the intersection does not warrant a traffic signal at this time or with the inclusion of the proposed development traffic additions.

Q: Cochrane Drive is already too narrow. There are issues with passing traffic including school busses and trash trucks.

A: The CMHP team noted that lane widening and new curb, gutter, sidewalks and setbacks would be provided along the Petitioner's Cochrane Dr. street frontage (and along all other frontage of the proposed development)

Q: Why should they (community meeting participants) believe what they are being told by CMHP?

A. District Council Person Al Austin responded in defense of CMHP and their history of quality projects and neighborhood building and that he was listening to their concerns

and would work with CMHP and the City to resolve issues as possible.

Q: The Multi-family Apartment site proposed along Cochrane Drive needs more than one entrance.

Q: There is a need to widen Cochrane and provide sidewalks.

A: The team responded with similar response to Cochrane roadway width issue noted above.

Q: The existing Murray Ave. and Grasset Ave. are narrow street sections and are used by southbound Statesville Rd. traffic as a shortcut to westbound Cindy Lane.

Q: There needs to be a new median cut on Statesville Rd. north for left turn onto Oakwood Dr.

A: The team noted that the developer and Petitioner do not have control over existing traffic patterns outside the boundaries of their specific site but could try to address with CDOT as part of ongoing conversations.

Q: The issue of CMS School impact was questioned.

A: As normal process of the Rezoning Petition, CMS reviews the plan and if the student capacity numbers for the proposed development is out of sync, then the petitioner will need to address.

Q: Directed to Council Person Al Austin: The area does not currently have a fire ladder truck. This may be necessary if multi-story apartments are proposed.

A: Similar to CMS, the Fire Marshall reviews all Rezoning Petitions for coordination and areas of concern and Petitioner would need to comply with any future Fire related requests required for approval of the Petition.

Q: Would it be economically feasible to not include multi-family within the Rezoning Petition?

A: No. CMHP believes in and promotes mixed-income neighborhoods that include multi-family and senior affordable apartments as vital to their Mission. These types of housing are the best way to include and achieve a mixed-income neighborhood.

Q: What has Brightwalk done for the area where it is developed?

A: Response by Council Person Al Austin; The Brightwalk neighborhood has sparked development of a new County Pool Facility , New Fire Headquarters, additional corridor and existing neighborhood re-development that replaced blighted housing.

Q: What types of 'activities' would there be for 17-22 year olds living within the new multi-family?

A: Each development is provided with clubhouse facilities including computer. The proposed development would also include park and open space as yet to be programmed.

Q: How is security handled for the multi-family?

A: All residents are screened prior to lease acceptance and residency. All adults are named on the lease and can be evicted if they break covenants of the lease. All facilities have daytime professional staff and are managed by professional leasing services.

Q. Can Open Space be provided behind the existing residential properties along Oakwood Drive?

A: The Petitioner noted that they would assess the site plan and see if any accommodations could be made for screening.

Q: What restricts new homeowners from purchasing a single-family residence and then

renting?

A: There can be HOA controls to mitigate this issue. The neighborhood will have governance by an HOA, of which CMHP will be a large part of for the long term as they will maintain control and ownership of their properties within the development.

Q: If the Rezoning were approved when would construction begin?

A: August 2016 at the earliest if the Multi-Family receives NCHFA funding.

Q: When would curb, gutter and sidewalk infrastructure begin?


A: Concurrent with Multi-family and street infrastructure within the next 2 years.

Q: Can Oakwood Dr. be widened?

A: The street widening is outside of the Petitioner's site area and responsibility but may become part of CNIP improvements in Neighborhood/Petitioner coordination with the City and CDOT.
