## General Review Information

The petition is located adjacent to Steele Creek Road, a State-maintained major arterial, south of West Boulevard, a State-maintained major arterial. The petition is located in a Lake Wylie wedge outside of Route 4, within the Westside Strategy Plan Use Changes.

## Active Projects Near the Site:

- CIP – West Blvd Realignment – (From Piney Top Dr to Steele Creek Rd)
  - Project Description: Widen existing Piney Top Dr and a portion of Byrum Dr to become the future West Blvd alignment. Realignment of existing West Blvd from Piney Top Dr to Steele Creek Rd will make room for airport's South End Around Taxiway expansion project. Project Phase: Construction; Estimated Completion Date: Q4 2025
  - CDOT PM: Corey Watt
- TIP – I-485 (TIP – I-5828)
  - I-77 to NC 49; Bridges 590661, 590662, 590663, 590664, and 590643. Rehabilitate pavement; Rehabilitate bridges.
  - Construction Year: 2029
- TIP – I-485 (TIP HP-0002)
  - Description: I-77 to I-85 in southwest Charlotte. Construct one express lane in each direction. This is a toll project (express lanes only; Right of Way: Funded for preliminary engineering only

Based on our review of the petition, we offer the following information for your consideration.

## Transportation Summary

The site is located adjacent to Steele Creek Road, a State-maintained major arterial, south of West Boulevard, a State-maintained major arterial. A Comprehensive Transportation Review (CTR) is not necessary for the complete review of this petition due to the conventional rezoning. A CTR will be required during permitting if the site generates site trips over ordinance thresholds. The site will be subject to transportation improvements in accordance with the UDO and the adopted CDOT Streets Map. CDOT will work with the petitioner during the permitting process to pursue all options to provide additional forms of connectivity that reflect the types of development associated with this place type and zoning district.

## Advisory Information

The following are requirements of the developer that must be satisfied prior to driveway permit approval. These requirements shall be reflected on the rezoning plan, as appropriate.

1. CDOT has the authority to regulate/approve all private street/driveway and public street connections to the right-of-way of a street under the regulatory jurisdiction of the City of Charlotte, per the City of Charlotte Unified Development Ordinance.
2. Adequate sight triangles must be reserved at the existing/proposed street entrance(s). Two 50' x 50' sight triangles (and two 10' x 70' sight triangles on NCDOT-maintained streets) are required for the entrance(s) to meet requirements. All proposed trees, berms, walls, fences, and/or identification signs shall not interfere with sight distance at the entrance(s) and shall be identified on the site plan.
3. The proposed driveway connection(s) to public streets will require a driveway permit(s) to be submitted to CDOT (and NCDOT on NCDOT-maintained streets) for review and approval. The exact driveway location(s) and type/width of the driveway(s) will be determined by CDOT during the driveway permit process. The locations of the driveway(s) shown on the site plan are subject to change in order to align with driveway(s) on the opposite side of the street and to comply with City of Charlotte Unified Development Ordinance regulations.
4. All proposed commercial driveway connections to a future public street will require a driveway permit submitted to CDOT for review and approval.
5. Any fence or wall constructed along or adjacent to any sidewalk or street right-of-way requires a certificate issued by CDOT.
