

## **COMMUNITY MEETING REPORT (SECOND MEETING)**

**Petitioner: Song Lu**  
**Rezoning Petition No.: RZP-2026-004**

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte Planning, Design and Development Department pursuant to the provisions of the City of Charlotte Unified Development Ordinance.

### **PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:**

A representative of the Petitioner mailed a written notice of the date, time, and location of the Community Meeting to the individuals and organizations listed on Exhibit A-1 by depositing such notice in the U.S. Mail in accordance with City requirements.

A copy of the written notice is attached hereto as Exhibit A-2.

### **DATE, TIME AND LOCATION OF MEETING:**

The second Community Meeting was held on April 9, 2026, at 6:30 PM, at 1720 Oakdale Road, Charlotte, NC 28216.

### **PERSONS IN ATTENDANCE AT MEETING:**

The Community Meeting was attended by those individuals identified on Exhibit B attached hereto. The Petitioner's representative at the Community Meeting was Chuda Dhimal of Dhimal Realty Inc., representing the Petitioner, Song Lu.

### **SUMMARY OF ISSUES DISCUSSED:**

The meeting began with an introduction of the Petitioner, Song Lu, and the Petitioner's representative, Chuda Dhimal of Dhimal Realty Inc., followed by an overview of the rezoning request. The purpose of the meeting was to present the updated site plan and provide an opportunity for additional community input.

The Petitioner presented the revised site plan, which reflects changes made in response to feedback received during the first community meeting and staff comments. The revised plan removes auto-oriented uses and instead focuses on general

commercial uses including retail, office, and medical. The Petitioner also explained that the development is limited to reuse of the existing building with no expansion of the building or parking area. The Petitioner explained that the revised plan includes landscape improvements, including a 25-foot buffer along residential property lines.

The meeting included an open discussion with attendees. Attendees were informed of the changes made to the plan and were given the opportunity to ask questions. Overall, the discussion was constructive and no significant concerns were raised regarding the revised plan.

The Petitioner informed attendees that the revised site plan has already been submitted to the City as part of the rezoning process.

### **CHANGES MADE TO THE PETITION AS A RESULT OF THE COMMUNITY MEETING:**

The revised site plan was presented at the meeting, and attendees were informed that it has been submitted to the City as part of the rezoning process following updates based on prior feedback.

No additional changes to the petition were identified as a result of the second community meeting.

### **CONCLUSION:**

The Petitioner thanked all attendees for their participation and feedback. Attendees were encouraged to contact the Petitioner with any additional questions or comments.
