

SECOND COMMUNITY MEETING REPORT

Petitioner: Olympia & Wright LLC

Rezoning Petition No. 2026-030

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning, Design and Development Department pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED: David W. Murray, a representative of the Petitioner, mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing such notice in the U.S. mail on July 20, 2026. A copy of the written notice is attached hereto as Exhibit B. A copy of the notice was also sent to all City Council members.

DATE, TIME AND LOCATION OF MEETING: The Community Meeting was held virtually on Zoom at the link provided in the community meeting notice on July 30, 2026, at 6:00 p.m.

PERSONS IN ATTENDANCE AT MEETING: The Community Meeting was attended by one (1) community members as shown on the list attached hereto as Exhibit C. The Petitioners were represented at the Community Meeting by David W. Murray (agent and attorney for Petitioner).

SUMMARY OF PRESENTATION/DISCUSSION: The Zoom meeting started at approximately 6:00 PM and ended at approximately 6:55 PM. A copy of the PowerPoint presentation made by Petitioner is attached hereto as Exhibit D.

Since Ms. Duren had attended the first community meeting, and Mr. Murray and Ms. Balogh for petitioner at met Ms. Duren at her property to look at stormwater issues on July 28, the discussion was primarily about reaching out to City officials to look at the stormwater pipe coming from Morning Drive which discharges directly towards Ms. Duren's house. Mr. Murray advised Ms. Duren that he was speaking with stormwater counsel and the senior engineer regarding the issues. He also advised that he would pass along those issues during a meeting he had upcoming with CM Mayo.

Mr. Murray showed a new survey prepared by Petitioner for the location of the proposed house. That plan shows that the new house will not contribute to the drainage issues. He also showed a City plan identifying the location of the pipes that were causing drainage onto Ms. Duren's property and that they were not located on or impacted by the proposed rezoning.

Mr. Murray advised Ms. Duren that he would continue to make her aware of any updates from stormwater officials.

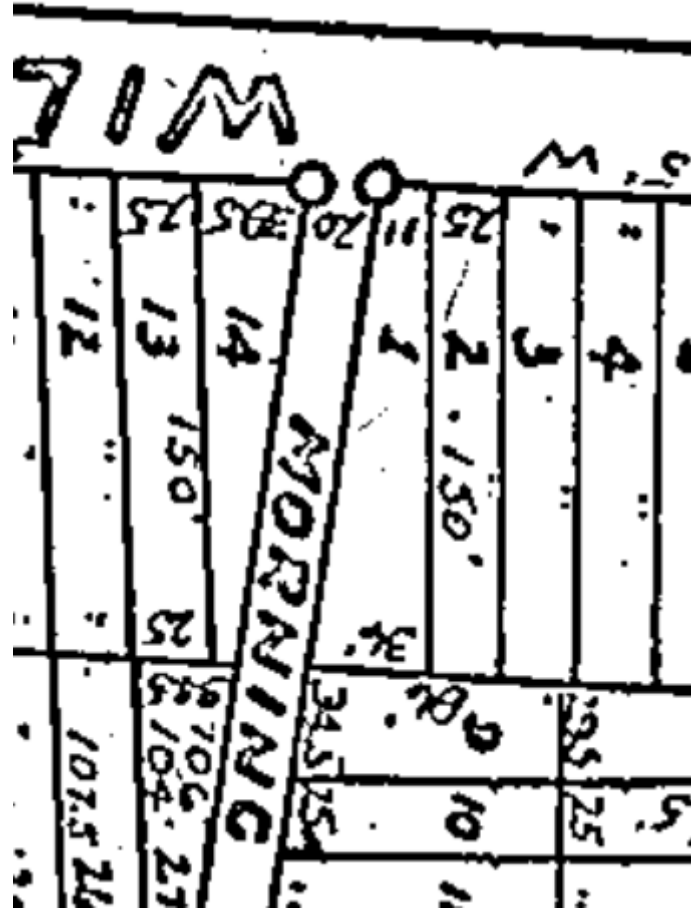

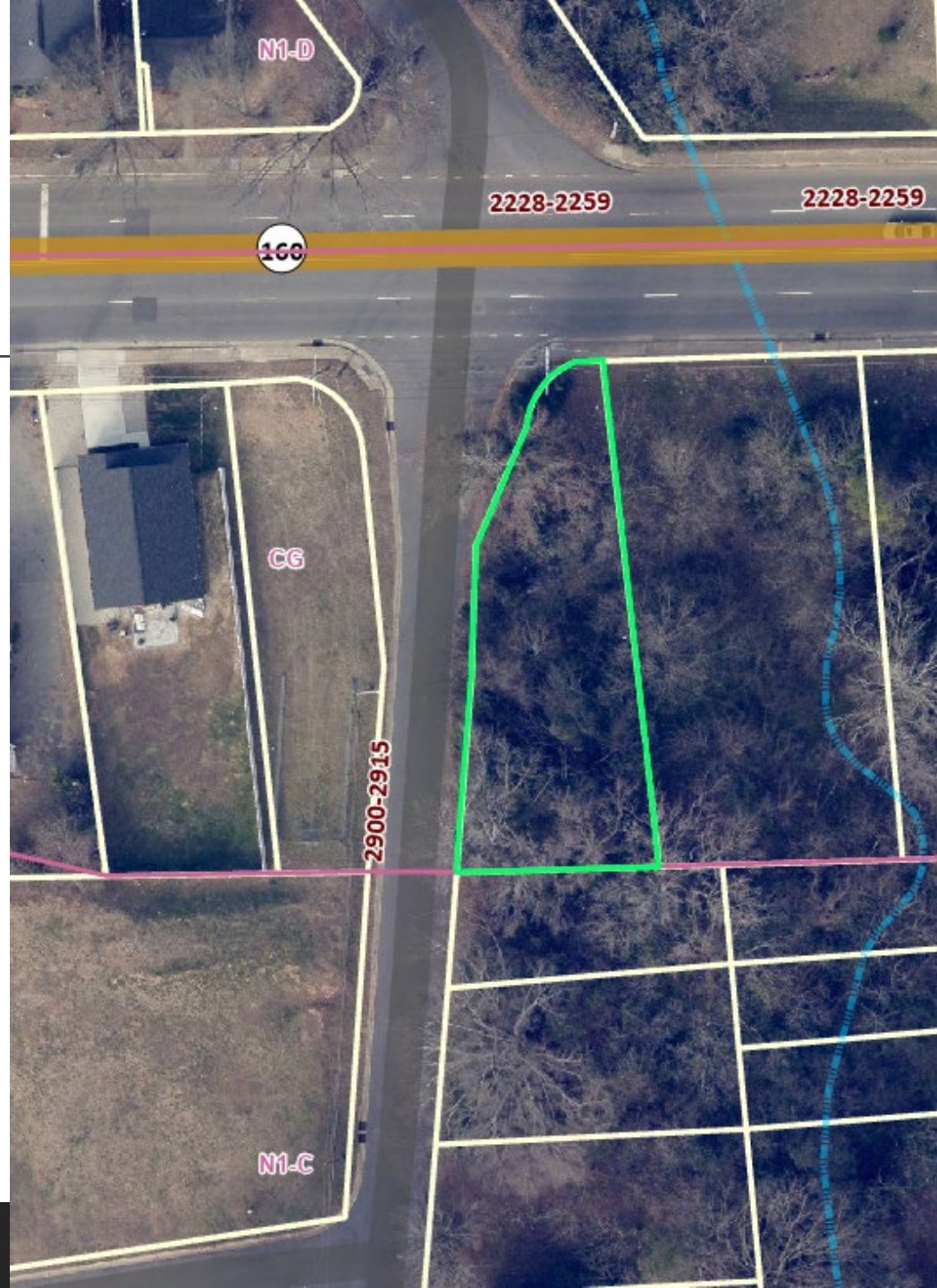
Existing Zoning – CG, General Commercial

Allows all types of general commercial uses typically found on major commercial corridors and roads.

Not typically fronting a street like Morning Drive which is residential in nature.

Area Zoning

- CG – General Commercial
- N1-D – Neighborhood 1-D
- N1-C – Neighborhood 1-C



Existing Uses

- This site is currently vacant.
- Property to the east is owned by the City of Charlotte and undevelopable.
- Property to the west is CG zoned but had a residential house built on it in 2022 before UDO change in 2023.
- Property to the north and south is residential.

Rezoning Process Generally

- There are two types of rezonings in Charlotte: conventional and conditional
- Conventional rezonings do not require a site plan and are limited only by the zoning ordinance.
- Conditional rezonings require a site plan with stated conditions and go through more detailed staff analysis and review before a determination is made.
- **This petition is a conventional rezoning without a site plan.**

Proposed N1-E Zoning District

- A single-family zoning district which allows single-family detached, duplex and triplex houses. The current CG zoning allows for single-family detached, duplex and triplex only if existing prior to 2023, thus the need for the rezoning.
- The reason for the N1-E as opposed to another N1 district is because of the small buildable lot size and width.
- Given that it is adjacent to a permanently undeveloped parcel owned by the City, smaller setbacks are reasonable.
- The existing CG zoning district is not feasible because a commercial use cannot be placed on the property because of its unique size and location.

Recommended Land Use Plan

- Place Type map for 2040 plan calls for Neighborhood Center (commercial/retail/etc) uses
- This rezoning petition is technically inconsistent with the 2040 Plan Neighborhood Center recommendation.
- This lot is too small to support a Neighborhood Center.
