**2024-143 by Panorama Development, LLC** for a change in zoning for approximately 11.2 acres located north of Parker Drive, west of Berryhill Road, and east of Remount Road from ML-1 & ML-2 to CAC-1(CD).

**2025-063 by Northwood Ravin** for a change in zoning for approximately 5.50 acres located west of Carnegie Boulevard, north of Fairview Road, and east of Park Road from OFC to RAC(CD).
