DETAILS OF APPROVED PROJECT: The project is a two-story detached accessory garage building located in the rear yard. The project also includes the removal of a small dilapidated shed structure. The new building measures 24'-6" x 26'-0" with a height of 23'-2" (see Elevation and Floor Plan Exhibit – May 2015, Revised). The building design is inspired by the main house, with a gambrel roof and dormers on both sides. The second floor will be accessed by an interior staircase and used for storage. Materials and details will all be wood to match existing on the main house, including lap siding, trim, corner boards, windows, etc. The garage doors will be steel with a recessed carriage house panel design and will be painted (see Garage Doors Exhibit – October 2015). The doors will be solid without the band of windows at the top as shown in the attached elevation. The project includes a new 20' wide paved apron the length of the garage (see Site Plan Exhibit – May 2015, Revised). A portion of the existing fence will be removed to construct the new garage. If any portion of the fence needs to be replaced post-construction, then a separate approval for the fence design is required. The structure will meet the minimum side and rear setbacks. Approval of any substitute material is not implied. See attached plans.

This Certificate is valid for a period of six months from the date of issuance. Failure to obtain a building permit in that time will be considered as a failure to comply with the Certificate and the Certificate will become invalid. If a building permit is not required, then the approved work must be completed within six months of the date of issuance of this Certificate. The Certificate can be renewed within twelve months of its issuance by Historic District Commission staff by written request and submission of a valid reason for failure to comply within the six-month deadline.






Cross Section*


