## Mandatory Referral Report No. 97-06 Charlotte-Mecklenburg Planning Commission Sale of City Owned Property March 1997

**Project Location and Description:** This project consists of .115 acre tract of vacant land at 624 Welker Street in the Cherry Community; Tax Code: 125-243-76.

**Project Proposal:** The City of Charlotte is considering the sale of this property pursuant to guidelines which call for the disposal of surplus properties.

**Project Justification:** City Council's Guidelines for Service Contracting and Asset Management requires that the City inventory and analyze City owned assets. Any asset not needed to achieve public purposes is to be sold to the private sector.

**Project Impact:** This property is located in a predominately single family area. The property is currently zoned R-6. A buyer has expressed interest in using the property to build new single family home. New housing is consistent with plan recommendations and should greatly benefit the neighborhood. Attached is a letter that states the buyer will use the property for residential.

Relationship to other public or private projects: The Cherry Small Area Plan, adopted by City Council in January 1993, states that the property is to be used for single family residential. Cherry is one of Charlotte's oldest neighborhoods, and the first neighborhood developed for home ownership for lower income residents. This project is consistent with the plan's recommendation to encourage the development of affordable single family homes on Welker Street.

**Project Cost:** The cost of the property is unknown at this time.

**Staff Recommendation:** The intent of the Cherry Small Area Plan is to provide new, affordable housing that is compatible with the existing character of the Cherry Community. Planning staff recommends sale of the property.

## **Planning Committee Recommendation:**

Planning Committee voted unanimously to support the staff recommendation to sell the property.
