Minutes:

Meeting began at 7:05 pm with introductions by Bill Drury, Behavior Health Center-CMC Randolph Representative.

After introductions, Mr. Drury began by explaining what services were provided at the facility, the relationship between Carolina's Health Care, the facility operator and Mecklenburg County, the facility owner.

Mr. Turner reviewed the site plan explaining relationships of the existing building and parking and the new building addition and new parking area expansion in relation to the parcels that were being rezoned. It was pointed out that even though the parking being indicated on the site plan included all of the parcels involved in the rezoning, the county did not intend to build all of the parking at this time, that approximately only 75 spaces would be added as part of the current project. The remaining parking would be built in the future, but there was no schedule at this time.

The buffer fencing detail containing the fencing and landscaping was discussed in detail. There were two questions concerning the height of the fencing and quantity of landscaping plants, which was satisfactory, answered. This information was contained on the Rezoning plan and was pointed out. There was a third question concerning the status of the counties acquisition of the parcels. It was pointed out that the county has completed acquisition of 8 of the 10 parcels and the final two were in condemnation proceedings.

Mr. Drury then reviewed the building floor plan in detail pointing out the new main entry and secondary entries into the emergency department and additional detail of services provided my the Emergency Department.

The meeting adjourned at 7:32 pm.
