
COMMUNITY MEETING FORM PETITION NUMBER 2007 - 118 <u>WESTBURY ROAD</u>

<u>Persons in attendance at meeting:</u> Attendance was taken with seventy – nine (79) persons signing the Sign-in Sheet (see attached).

Garry Smith with Brookechase Properties and Chip Cannon with Urban Design Partners along with Walter Fields and Susan Cannon of Kimley-Horn and Associates attended the meeting on behalf of the Petitioner.

Summary of issues discussed and changes made as a result of the meeting:

Before the required community meeting, the Petitioner had held several meetings and conversations with adjacent property owners and residents in the area. As a result of these previous communications, the proposed site plan has undergone numerous revisions to address residents' concerns.

At the community meeting held on November 26th, many of the same issues discussed previously with the closest neighbors were discussed again. The meeting began with brief introductions and an explanation of the rezoning process including key dates for the petition. The meeting then moved to a discussion of where the project began and where the project has evolved to, including a description of the site plan, the mix of condominiums and single family housing, the location of parking, the preservation of tress on the site and the access to the property. Concerns expressed by those in attendance including the density of the project, the height of the proposed buildings and the traffic that would be generated by the project. Additionally, there were also a number of comments about other developments in the area such as Rosewood.

A number of site plan modifications have been made to the site plan as a result of review comments from staff agencies but no changes have been made at this time as a direct result of the community meeting.
