
Persons contacted and explanation of how contacted: Meeting invitees were contacted by first class mail. (See attached letter and mailing list).

I am a zoning/planning consultant and on behalf of Duke Energy Corp (Duke), I would cordially like to invite you to a community meeting to review rezoning petition 2010-20. Duke recently filed the rezoning request for a site located on NC Hwy 51 next to the City of Charlotte Fire Station 24. The community meeting is part of the rezoning process of the City of Charlotte and you have been or shortly will be officially notified of the rezoning request by the Charlotte-Mecklenburg Planning Department.
