Mr. Fields opened the presentation with a description of the site and the proposed development as well as an overview of the rezoning process. There were several questions about the type of apartments being proposed and about the details of the site plan. It was noted that the buildings would all have elevators that would be attractive to active adults and to Wounded Warriors that would find the accessibility and the interior accessibility features valuable. The building plans were presented and discussed there were but no real questions or concerns about the proposed use or the density at that location.

A number of site plan modifications have been made to the site plan as a result of review comments from staff agencies but no changes have been made as a direct result of the community meeting.
