Patterson explained the rezoning process in general and stated that the purpose of the community meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

- 7. What are the additional cost that will be incurred due to the conditional re-zoning such as paving the driveway and parking spaces, planting more trees, etc.?
- 8. How will these items be paid for?
- 9. Why are these items needed for a structure that is already in place?
- 10. What will happen if the rezoning is not granted?
- 11. Does FOCC think the rezoning request will be granted?

Dona thanked the attendees for coming to the Community Meeting and requested their support on this rezoning request.
