Walter Fields attended the meeting on behalf of the Petitioner.

#### Summary of issues discussed and changes made as a result of the meeting:

Mr. Fields opened the presentation with a description of the site and the proposed development as well as an overview of the rezoning process. This is a rezoning and a site plan amendment that will essentially relocate a previously approved storage facility to another location on the previously approved Pinnacle Point master planned development. There was some discussion about the relocation of the storage use and how the plan would be amended to return the former storage site to the previously approved plan and the unique nature of the buildings. Two of the attendees were representatives of the owners of the adjoining tract and discussion focused on how the two sites would relate to one another and how both parties could work together to improve access to both parcels. There were questions about security and the type of lighting that is contemplated. Building designs were presented and more detail was requested. Discussion also dealt with timing of the development but no real questions or concerns about the proposed development were raised.

A number of site plan modifications have been made to the site plan as a result of review comments from staff agencies but no changes have been made as a direct result of the community meeting.
