

Community Meeting Report for Rezoning Petition No. 2015-028 (Cherry Site B)

Petitioner: Charlotte Housing Authority (CHA)

Rezoning Petition No. 2015-028

Property: 1.035 acres located in between Baldwin Ave, Luther St, and Main St.

Requested change in Zoning from R-8 to R-22 MF (CD), for the development of 22 multifamily rental units.

MEETING SUMMARY – PETITION No. 2015-028 - SITE B

Overview of Petitioner's presentation:

This rezoning is one of five rezoning requests the petitioner is requesting for the Tall Oaks Redevelopment in the Cherry Community. There was an overall presentation of the entire development plan, then each site was presented in more detail (see **Exhibit D** for presentation boards) with a question & answer and feedback session each rezoning request, and a review session at the end for additional questions/comments for all sites.

Introduction

Sylvia Bittle-Patton opened the Meeting

Invocation by Doris Dennis

Sylvia informed attendees that February 16th, 2015 is the date of the public hearing for these requests and that City Council is set to make a final decision in March.

A. Fulton Meachem Jr. - CEO & President of Charlotte Housing Authority

Introductions of representatives

Overview of how we got here - there has been a paradigm shift in Public Housing over the last 10 years. CHA moved from isolated housing to housing of choice for mixed income families. The federal government has moved from a segregated public housing model, because it's been shown that it is not a sustainable model, they've been cutting funds across the country, and there is no money to upkeep the units. So, where do we go from here? How do Housing Authority's shift to something that acts and behaves with the market?

Reference to the handout sheets for each phase (see **Exhibit E *scan in***) – there will be no public housing on any sites. There is a full working requirement for all residents ages 18+. There will now be new safety amenities we're adding including defensible space in the design and enhanced security features as components of the plan.

For Phase 1 – This will be affordable housing that is for the working income group making below \$38,000. The developer is pursuing North Carolina Housing Finance Agency tax credits to assist in funding this phase.

For Phase 2 – This will be housing that is for the middle class bracket, of the working income group making approximately \$38,500-\$77,000. The marketplace is squeezing out the middle class in the market place. So, we're providing an option for these working families. This includes teachers, nurses, etc. CHA wants to create a community design for working families to come live, work, and play here in Cherry.

We will have time in the end for questions but we will get into structured component for CHA sites.

Daniel McNamee then provided an overview of each Rezoning site.

Overview of Petition # 2015-028 – Site B

Daniel McNamee presented the development plan for Site B. He stated that the smaller sites, sites B-F are scattered throughout the neighborhood, and that when we refer to phase 1, we're referring to the NCHFA tax credit sites, which is a total of 81 units. He referred to the handouts (**Exhibit E**) regarding the phases. Across from Cherry Neighborhood Park, this site currently has 2 duplexes and an office on there. He referenced the site boards. We're proposing a 3 story building for a total of 22 units. 80 feet long. Broken up with alcoves for stairs. It's made up of flats and townhomes. There are pedestrian entrances onto all 3 streets. At the end is a clubhouse with picnic shelter & a playground for the redeveloped community. Parking access to the site is from Main Street, per our conversation with the neighborhood,

saying that there was already enough traffic on Luther, where we originally had the entrance to the site. There are 28 parking spots, 6 that are for the clubhouse, and 22 that are for the units. Current zoning is R-8 and proposed is R-22 MF (CD). We designed to stay close to the heights in context and saved the trees along the front. Those surrounding single family homes are about 30 feet, and we stayed at about 30-40 feet. We saved trees on all sites to help meet the tree ordinance requirements and preserve the character of the neighborhood.

Questions & Comments for Petition # 2015-028 – Site B

Q: What is the parking here? Where is the excess parking at?

A: There's 1 car / unit, it's accessed off Main Street, 22 parking spaces for units, plus 6 for community center. There is no additional parking.

Comment: Most households will have more than 1 car and the additional vehicles will end up parking on the street.

A: This is household income level of \$38k and below so you may not have even one car per household. I don't think parking will be an issue.

Q: I have a 17 year old right now. I have a car, he has a car. Where is he supposed to park?

A: I'm only saying that this is what we're proposing. If we have to make so that there's only one car per family then we'll look at that then, upon entry for residents back into the property. And if someone does have more than one car then maybe they can look at other housing options we may have, something else may fit them better with potential to park more cars, this is just one site. And if you are presently a Tall Oaks resident you will have first option on those units. There a lot of residents right now that don't have two cars.

Q: Are the stairways enclosed or open breezeways?

A: They are open but are covered. And recessed back. You would access all three levels from this breezeway. Townhomes on the end with porches and flat on the ground and above.

Q: Is there ADA/accessible flats for elderly? And do they have priority over these? Is there flats on the lower level?

A: Yes, 10 accessible units scattered throughout, we have more than enough, and it is a requirement for the tax credits. For elderly and disabled there is no work requirement, eligibility criteria must be met.

Q: Do you have enough units so that all residents who are relocated can come back?

A: Oh yes, absolutely. That was a requirement, so that we have the same unit configurations as before. Every resident that wants to come back can come back, upon meeting the requirements, they have to meet the eligibility criteria.

Q: \$38K seems a lot to me. How is rent calculated?

A: Based on a family of 4? Rent is based on income, so it's affordable. So, really \$38k isn't really a lot.

Q: Question about the community center, is it for all Cherry residents?

A: The community center is for the residents of the affordable phase, limited access will be available to certain areas by the neighborhood.

Q: Because it's for tax credits/low income, does it make it exempt from screening & storm water requirements?

A: No, those are still requirements, not exempt from either. The proposal would be here to go subgrade for storm water. From a planning perspective they don't look at income at all.

Q: How many 4 bedrooms are there in the whole plan?

A: 2 total 4 BR units in the entire plan.

Q: When the plans are submitted for approval, who's tracking the trees that are taken down?

A: Land Development looks at it.

Q: So do they have to look at that beforehand?

A: Yes, after rezoning you still have to go through permitting, and part of that is to go back before the city and county to make sure our building meets code and the sites meets the ordinance.

Q: So this site is on about 1 acre of land. This is a viable site, why can't site A be more viable with less units like this one? This is one acre, 22 units, so why couldn't you do the same for A?

A: This is a component of a total of the whole development, within 81 units, here we have 22 units of 81. We could do 4 of these buildings on site A and we could surface park them all, and it'd be under the current zoning, but that's back to his point from our preliminary meetings with the community that they

didn't really like surface parking. And so to be able to close that deck, it's not affordable to do it with less units. So this building could be replicated on site A but it's going to be surface parked and it's probably going to tear down more trees.

Q: Any other features you can add to the existing park rather than put up another one?

A: We looked at that extensively, but with the community we came to the conclusion that we were going to have it separate. NCHFA is pretty strict and a play area is required for this site.

Sylvia Bittle-Patton: Let me clarify that it's not that we wanted it to have your own, we just didn't want the building going at our existing historic park. We didn't want the rental office there, and for the NCHFA you did need a playground.

Q: The community center has a rental office in it?

A: Yes.

Comment made regarding this site, later on in the meeting: They like the architectural elements from the quad on Site C & would like similar features for this building.

Closing Session with General Questions & Comments for Rezoning Sites

Q: With the feedback I'm hearing, C is the only one with good feedback. Can the design for Site C be utilized elsewhere?

A: We could possibly pull in similar architectural elements, but some parcels wouldn't allow it because of the setbacks, this building is deeper than the other quad and the townhomes. But we can try to incorporate some of the elements, with the similar residential character.

Comment: We are not a "UR" neighborhood. We do recognize that a lot of the parcels don't fit in with the plan, and we should find compatibility.

Any other questions?

Q: There's been talk about Cherry becoming a historic neighborhood/district. How would these sites honor the historic character of the neighborhood? How do you think you will coordinate?

Sylvia Bittle-Patton replied: For the local historic designation - we'd still qualify, only existing homes of a certain age would be included within the historic district. Is it economically feasible for individuals to do this for the neighborhood? We don't know. A historic district would require all renovations to be rehabbed in the historic manner, and it may not be economically feasible for existing landowners, because of the price of rehab. We are looking into pursuing a Conservation District - first in the city. It wouldn't affect the application. It wouldn't qualify or disqualify us.

Q: When would construction begin?

A: 2016 construction would begin in early spring, it'd take about 24 months total for Phase I and II.

Q: When are you going to start relocating the residents?

A: Possibly early summer, once we know if funding has been received for Phase I.

Janelle Brown closed out this portion of the meeting and thanked the attendees.

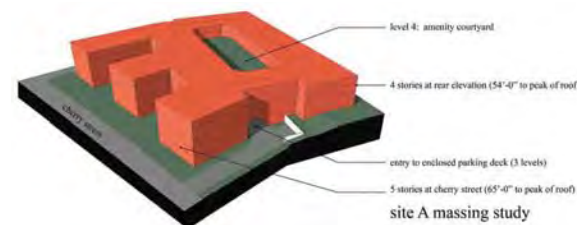


TYPICAL UPPER FLOOR PLAN
