SUMMARY

Two members of the community attended the meeting. One attendee owns a nearby business on Ed Brown Road. He asked the Petitioner's representatives about the most likely traffic patterns for traveling to and from the site. He also expressed concerns about the condition and maintenance of Ed Brown Road.

The second attendee is a resident of the adjoining neighborhood and resides on Steele Meadows Road. She was interested in the proposed use, the layout of the site and the relationship to her property and neighborhood.

Due to the small number of attendees, the Petitioner's team engaged in informal discussions with the attendees. Mr. Brown used a PowerPoint presentation, attached hereto as <u>Exhibit D</u>, to explain aspects of the proposed rezoning.

Councilmember Mayfield joined the meeting and asked several questions about the proposed facility and its operations. She and the Petitioner's team discussed the design of the proposed warehouse and potential noise impacts on adjacent residents. Finally, Ms. Mayfield and the Petitioner's team discussed opportunities for greater community involvement and local hiring.


