DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Thursday, February 25 at 6:00 p.m. at the LYNX Blue Line Extension Field Office which is located at 8401 University Executive Park Drive, Suite 130, Charlotte, NC 28262.

The Community Meeting was attended by those individuals identified on the sign-in sheet attached herto as <u>Exhibit C.</u> The Petitioner was represented at the Community Meeting by Andy Mock and Hillary Ryan.

SUMMARY OF PRESENTAITON/DISCUSSION:

The Petitioner's agent, Andy Mock, welcomed the attendee and introduced the Petitioner's team. Andy Mock indicated that the Petitioner proposed to rezone an approximately 0.11 acre site ("the Site") located at 9100 Robert D Snyder Road. The purpose of the rezoning is to permit the development of a pedestrian tower and bridge, connecting to the future LYNX Blue Line JW Clay station, inclusive of way finding signage that exceeds the TOD allowable limits. Andy Mock explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

Andy Mock provided background about his experience and the typical operation of the City. HE then presented the site plan and pointed out various commitments made by the Petitioner. Andy Mock showed proposed architectural elevations and discussed the design of the proposed facility. He used the elevations and renderings to explain the facility's design concepts and operations.

Mr. Franz asked about where the CATS sign would be located on the pedestrian bridge, specifically and Andy Mock pointed out that information. Mr. Franz also asked about who at the University made

decisions regarding placement of external signage and Andy Mock discussed the large integrated team of UNCC and City of Charlotte staff who work to continuously communicate about the project.
