COMMUNITY MEETING REPORT

Petitioner: Ministerio Internacional Nueva Vida, Inc.

Rezoning Petition No. 2016-061

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

PERSONS AND ORGANIZATIONS CONTACTED WITH DATE AND EXPLANATION OF HOW CONTACTED:

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on <u>Exhibit A</u> attached hereto by depositing such notice in the U.S. mail on (4/6/2016). A copy of the written notice is attached hereto as <u>Exhibit B</u>.

DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on (4/16/2016) at (6:00 pm) at (5935 Wilora Lake Road).

PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit C. The Petitioner was represented at the Community Meeting by Scott Stevens (Agent) and Alex Montoya (Associate Pastor).

SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's agent, Scott Stevens, welcomed the attendees and introduced the Petitioner's team. Scott Stevens indicated that the Petitioner proposed to rezone an approximately 20 acre site (the "Site") near 5935 Wilora Lake Road from the R-3 to Institutional (CD) zoning designation. Scott Stevens explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

Ministerio Internacional Nueva Vida, Inc. provided background information about the Petitioner's experience and the typical operation of its facilities. He/she then presented the site plan and pointed out various commitments made by the Petitioner. Scott Stevens showed proposed architectural elevations and discussed the design of the proposed facility. He/she used the elevations and renderings to explain the facility's design concepts, and operations.

The meeting started promptly at 6:00 pm and lasted until the last questions were answered at 8:23pm on 4/15/2016. A headcount of 37 neighbors and interested parties was noted with 27 signing in on the sign-up sheet. Also in attendance was the Councilman for the district, John Autry who also engaged with the residents and listened to common concerns. Overall, the attendees were welcoming of the church but had some traffic and environmental concerns. Some of the main points of interest we noted are listed below:

- 1. Connectivity of Wilora Lake Road and elevated speed and safety issues associated.
 - a. Petitioner conveyed their original proposal NOT to connect Wilora Lake Road but rather use the 'paper roads' of First Street and Vernedale Road to gain access to either side of the proposed parking lot.
 - b. Petitioner also explained that is was CDOT's recommendation for Petitioner to provide the connectivity.
 - c. The City recently held a Community Meeting for a nearby proposed school rezoning. The neighbors in attendance seemed to feel that the City showed no desire to open up the road.

- 2. Environmental impact on the downstream lake.
 - a. The neighbors were concerned that the stormwater runoff would negatively affect the habitat in and around the lake.
 - i. Petitioner assured that the City has strong guidelines in their recommendations to protect the lake buy using high-hazard silt fence, detention before the existing forebay as well as other measures to ensure safe construction practices.
 - b. Concern about contaminants from vehicles parking at the church being addressed.
 - i. Petitioner sited City Stormwater's comments for run-off protections.
 - ii. Petitioner explained that current zoning allows for up to 60 single-family residential homesites to be built on the property which would impact the stormwater 24/7 whereas the church only meets intermittently.
- 3. Multi-use bike and walking path proposed by CDOT in the paper right-of-way portion of Vernedale Road
 - a. Liability concerns of "Attractive Nuisance" around the waterway
 - b. Concerns of people parking at the dead-end of Vernedale and walking to the church
 - i. Petitioner explained that it could live with or without the multi-use path and would follow the direction of CDOT and City Stormwater Department
- 4. Loss of trees and lighting impact
 - a. Petitioner again explained that the current R-3 designation would affect both treesave and lighting in a larger way than that of a church facility with regards to parking and field lighting
 - b. Petitioner also explained that this was a great opportunity to ensure that SFR or other highimpact uses will not implemented and that approximately 3 times more trees could be protected under this petition.
- 5. Pedestrian foot traffic through the yards of tax parcels 10310213 through 10310221 would be eminent.
 - a. Neighbors would like to see a fence/barrier to discourage trespassing
 - i. Petitioner agreed to follow the direction and advice of the City Planning Department
- 6. Zero tax base
 - a. Petitioner explained that, although true, religious institutions have a long track record of relieving municipalities of many social and economic burdens in the community with volunteers and community action. Additionally, churches draw weekend and mid-week attendees who frequent local business for dining and retail benefit.


