# Petition Number: 2016-132 Parcel No. 187-01-103; 5108 Sardis Road

COMMENTS: No trees can be planted in or removed from the right of way on Sardis Road without permission of the City Arborist's office. Contact Laurie Reid (704-336-5753) at the City Arborist's office for a permit before removing trees in the right of way.

The petitioner must submit a tree survey for all trees 2" or larger located in the rights of way. In addition, the survey shall include all trees 8" or larger in the setback of all roads.

### Petition Number: 2016-133 Parcel No. 219-121-12; 13425 South Tryon Street

COMMENTS: No trees can be removed from or planted in the right of way of South Tryon Street without permission of NC Department of Transportation and the City Arborist's office. Tree must be planted to meet NCDOT planting guidelines. Contact Lewis Hatfield (704-336-4265) at the City Arborist's office for a tree planting permit before planting trees in the NCDOT right of way once plans have been approved by the City.

The petitioner must submit a tree survey for all trees 2" or larger located in the rights of way of all three roads. In addition, the survey shall include all trees 8" or larger in the setback of South Tryon Street.

#### Petition Number: 2016-134 Parcel No. 061-092-02; Ashley Road/Joy Street

COMMENTS: Street trees in the right of way on Ashley Road, Joy Street, and Bullard Street are protected by the Tree Ordinance. No trees can be removed from or planted in the right of way without permission of the City Arborist's office. Contact Laurie Reid (704-336-5753) at the City Arborist's office for a permit before removing trees in the right of way.

The petitioner must submit a tree survey for all trees 2" or larger located in the rights of way of all three roads. In addition, the survey shall include all trees 8" or larger in the setback of all three roads.

COMMENTS: Street trees in the right of way on West Tyvola Road protected by the Tree Ordinance. No trees can be removed or planted in the right of way without permission of the City Arborist's office. Contact Laurie Reid (704-336-5753) at the City Arborist's office.

No trees can be planted in the right of way of South Tryon Street without permission of NC Department of Transportation and the City Arborist's office. Tree must be planted to meet NCDOT planting guidelines.
