The required Community Meeting was held on Tuesday, February 6, 2018. A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on <u>**Exhibit A**</u> by depositing the Community Meeting Notice in the U.S. mail on 1/25/18. ## TIME AND LOCATION OF MEETING:

The Community Meeting required by the Ordinance was held on Tuesday, February 6<sup>th</sup>, 2018 at 6:30 PM, at Charlotte Powerhouse Studio, 1507 Camden Rd, Charlotte, NC 28203.

The Petitioner's representatives at the required Community Meeting were Emma Littlejohn and Shawn McAllister with South End West Syndicate and Colin Jenest with ColeJenest & Stone. Also in attendance was Bridget Grant with Moore & Van Allen, PLLC.

## SUMMARY OF ISSUES DISCUSSED AT MEETING:

## I. <u>Overview of Petitioner's Presentation.</u>

## Introduction and Overview of Development Plan.

Bridget Grant opened the meeting and welcomed everyone in attendance. Ms. Grant introduced Emma Littlejohn and Shawn McAllister, the petitioners with South End West Syndicate, LLC and Colin Jenest, the designer with ColeJenest & Stone.

Ms. Littlejohn gave an overview of their company and expressed that they have extensive experience in residential development.

Ms. Grant then went over the rezoning process and pointed out key meeting dates along the way. She then reviewed the site location and its vicinity to both office and multi-family uses. The land use plan calls for transit oriented, multi-family, and mixed-use development.

Ms. Littlejohn then explained the proposed land uses for the Site. The plan calls for 45 residential units with active ground floor uses and parking. The building will integrate the residential feel of the neighborhood and include pockets of open space.

The meeting was then opened for questions.

## II. <u>Summary of Questions/Comments and Responses:</u>

Attendees asked about the parking garage and how it would be presented to the street. The parking deck will be integrated into the building with residential units above on floors 2-5. The Petitioner conveyed they will meet the parking requirements.

Additional details were requested on the exact unit mix. Ms. Littlejohn expressed that through her research, the Charlotte market will support the range of unit types currently being contemplated.

Attendees then shared their perspective on aesthetic and proposed uses for the building. They inquired if building materials and exterior presentation to the neighborhood had been determined. The plans call for a combination of solid materials with design elements that meet many of the goals of the recent South End Vision Plan. The Petitioner plans to bring a meaningful frontage to the neighborhood with seamless architecture. Attendees asked about possible uses for the commercial portion on the ground floor of the development. Ms. Littlejohn informed the audience that specific tenants have not been identified.

There were questions about traffic and how the development may impact the community. Ms. Grant reviewed the trip generation table and described the proposed right turn from S. Tryon St. onto Woodcrest Avenue improvements.

Attendees asked about stormwater detention. Mr. Jenest told the audience that the plan currently contemplates an underground detention system. Final plans for stormwater detention are determined through the permitting process.

The Petitioner explained it is unlikely that proposed elevations will be included in future submittals. However, detailed development standards will be provided.

Ms. Grant thanked everyone in attendance and the meeting was adjourned. Attendees were encouraged to stay and ask additional questions should they choose.
