	This Community Meeting Report is being filed with the Office of the City Clerk and Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.			
Minutes:	The following items were discussed			
	Ms. Colony introduced herself and Mr. Short, and then explained their purpose for attending the meeting.			
	Ms. Colony described the project context within the Madison Park area. She and Mr. Short provided information about the site plan amendment, building size, architecture, proposed unit breakdown, parking, screening, and buffers. She also discussed the proposed right of way offering street frontage for the project as the reasoning for the proposed sidewalk location along Woodlawn Road. Ms. Colony shared a conceptual rendering of the site plan and conceptual cross section renderings of the building in relation to adjacent properties. The conceptual renderings are indicative of the circulation, landscape area, and general aesthetic of the final product.			

## Questions/Comments by Neighbors:

- How tall will the townhomes be?
  A: No more than 40' and no more than 3 stories.
- 2. Why are there no longer detached garages?A: The project budget was unable to work at the density originally planned, and so we had to add units in order to make the project feasible.

3. What will the buffer look like?

A: Along the west side of the property, there will be a 6' tall screening fence and additional trees planted. Along the east side of the property there will be a mixture of evergreen trees, canopy trees, and shrubs to provide screening at various heights.

4. Where will visitors park?

A: There are 6 surface parking spaces, and each unit has space for 2 vehicles in the garage.

- How will waste removal be handled?
  A: Each unit will have a roll out container.
- 6. Will there be patios or activated spaces that face adjacent properties?A: There are currently plans for there to be juilet balconies on the rear of the buildings. There has also been a space located between buildings 3 and 4.
- 7. Where will the stormwater go?

A: Currently the plan is to capture all the stormwater underground and it will infiltrate into the soil, and overflow will tie into the existing storm structure on site.
