The required Community Meeting was held on Monday, March 4<sup>th</sup>, 2019, a representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on **Exhibit A** by depositing the Community Meeting Notice in the U.S. mail on 2/13/2019. A copy of the written notice is attached as **Exhibit B**.

### TIME AND LOCATION OF MEETING:

The Community Meeting required by the Ordinance was held on Monday, March 4<sup>th</sup>, 2019 at 6:30 PM, at Good Shepherd Church – Room 320, 13110 Moss Road, Charlotte, NC 28273.

### SUMMARY OF ISSUES DISCUSSED AT MEETING:

### I. <u>Overview of Petitioner's Presentation.</u>

#### Introduction and Overview of Development Plan.

Bridget Grant opened the meeting and reviewed the site location. Ms. Grant introduced Michael Slavotinek with LIDL US Operations, LLC who gave a brief overview of LIDL. LIDL has 66 stores in 9 states that offer high quality goods at low prices. They strive to use local suppliers and give back to the community.

The proposed site plan includes sidewalk and street trees along Tryon Street and Moss Road. The building will be constructed with a substantial amount of glass on the S Tryon Street elevation.

Additional transportation improvements are still under consideration with CDOT and NCDOT.

Ms. Grant reviewed the conditional rezoning schedule and the meeting was opened for questions.

### II. <u>Summary of Questions/Comments and Responses:</u>

One attendee had concerns with traffic impact and safety at the intersection of Moss Road and South Tryon Street.

The Petitioner is working to mitigate the impacts and has had meetings with CDOT and NCDOT to provide dedicated right turn lanes into the site along S Tryon St and Moss Road. They are also working to include a left turn into the development from Moss Road towards South Tryon to mitigate traffic concerns.

Bridget Grant thanked everyone in attendance and the meeting was adjourned.

# CHANGES MADE TO PETITION AS A RESULT OF THE MEETING:

The Petitioner is continuing to work with CDOT to mitigate traffic impacts.
