Summary of issues discussed and changes made as a result of the meeting:

Mr. Fields opened the presentation with a description of the site and the proposed development as well as an overview of the rezoning process. He also described the history of this particular rezoning case and its conversion to a Conditional rezoning case at the request of the Planning Staff. In general the proposed multifamily community was viewed as a positive in that it fills a segment in the housing market and that the site plan is sensitive to the surrounding community. Mr. Rosenburgh answered several questions about the unit mix and the timing of the development. No changes were made to the plan as a result of the community meeting but several changes had been made in response to staff comments.
