PERSONS AND ORGANIZATIONS CONTACTED WITH DATES AND EXPLANATIONS OF HOW CONTACTED:

The required Community Meeting was held on Tuesday, April 2, 2019, a representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on <u>**Exhibit A**</u> by depositing the Community Meeting Notice in the U.S. mail on 3/20/19. A copy of the written notice is attached as <u>**Exhibit B**</u>.

TIME AND LOCATION OF MEETING:

The Community Meeting required by the Ordinance was held on Tuesday, April 2, 2019 at 6:30 PM, at Independence Regional Library, 6000 Conference Dr, Charlotte, NC 28212.

The Petitioner's representative at the required Community Meeting was Jensie Teague with Eastside Connections JV, LLC. Also in attendance were Bridget Grant, Land Use Consultant, and Dujuana Keys with Moore & Van Allen, PLLC.

SUMMARY OF ISSUES DISCUSSED AT MEETING:

I. <u>Overview of Petitioner's Presentation.</u>

Introduction and Overview of Development Plan.

Bridget Grant opened the meeting and welcomed those in attendance. Ms. Grant then reviewed the previously approved rezoning of the site and highlighted the progress that has been made. Ms. Grant explained that the new rezoning has been filed in order to increase the allowed square footage for the site to accommodate a future tenant. Jensie Teague, the Petitioner, went on to explain that this new request will allow an additional 15,000 sq. ft. of development in a two-story building.

The meeting was then opened to questions.

II. <u>Summary of Questions/Comments and Responses:</u>

Attendees inquired if the new building would be limited to two-stories. Bridget Gant explained that the previous conditions of the originally approved rezoning petition will remain in place, allowing a maximum height of 65 ft. in the MUDD zoning areas.

Attendees asked questions regarding specific tenants, amenities and project timing. The Petitioner provided a list of current leases and potential construction timing and explained that the rezoning will not be tenant specific.

Ms. Grant thanked everyone for their attendance and the meeting was adjourned.
