We invite you to attend a neighborhood meeting to receive a presentation on a rezoning petition for approximately 29 acres located adjacent to the Interstate 485 right of way and adjacent to the Seaboard Coast Line Railroad right of way, north of Old Moores Chapel Road. The purpose of this request is to allow a technical amendment to the existing zoning plan originally approved in 2005, to permit townhome development in an area that had been designated for multifamily housing. Summary of issues discussed and changes made as a result of the meeting:

Mr. Fields opened the presentation with a description of the site and the proposed development as well as an overview of the rezoning process. He also explained the history of the site and that the request was a technical change to the plan to allow townhomes in an area previously shown as traditional multifamily housing. There were questions about the site plan and the improvements that would be made as part of the development of the site. Questions about storm water, property values in the area, traffic on Mt. Holly Road, and the anticipated price of the homes. No changes were made to the plan as a result of the community meeting but several changes were made in response to staff comments.
