### COMMUNITY MEETING REPORT Petitioner: Carolina Development Group, NC, LLC Rezoning Petition No. 2019-092

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

### DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Thursday, September 5, 2019 at 6:00PM at the project site (Equipment Design & Fabrication, Inc., 722 N. Smith Street, Charlotte, NC 28202).

#### SUMMARY OF PRESENTATION/DISCUSSION:

The Petitioner's agent, Matt Langston, welcomed the attendees and introduced the Petitioner's team. Langston indicated that the Petitioner proposed to rezone an approximately 1 acre site at 712 N. Smith Street from I-1 zoning to UMUD-O zoning. Langston provided a handout explaining the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners.

Langston and Jon Krueger presented the site plan and architectural concepts to attendees.

Attendees included representatives of Archer Daniels Midland (ADM) who owns the industrial facility across Smith Street from the site. They provided information about their operations, in particular about truck movements through their site and along N. Smith Street. They had questions about whether the project would close Smith Street to outbound (southbound traffic) at any time. The Petitioner indicated that the northbound lane may be closed temporarily during streetscape or utility work, but outbound/southbound traffic should remain unobstructed throughout construction.

The meeting concluded approximately 8:00PM.
