# Petitioner: Artistic Contractors Inc. (Andrew Parker)

**Rezoning Petition No. 2019-094** 

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

A representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A attached hereto by depositing such notice in the U.S. mail on 8/1/2019. # DATE, TIME AND LOCATION OF MEETING:

The Community Meeting was held on Tuesday, September 3<sup>rd</sup> 2019 at 5:30 PM at Heist Brewery (2909 N. Davidson Street #200, Charlotte, NC 28205). The Petitioner presented at a regularly scheduled NoDa Neighborhood and Business Association (NoDa NBA) Community Meeting.

# PERSONS IN ATTENDANCE AT MEETING (see attached copy of sign-in sheet):

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as Exhibit C. The Petitioner was represented at the Community Meeting by Andrew Parker, Drew Rivas and Daron Gaon.

# SUMMARY OF PRESENTATION/DISCUSSION:

The NoDa NBA President, Jacob Horr, started the meeting and eventually introduced Rezoning Petition No. 2019-094. Andrew Parker welcomed the attendees and introduced the Petitioner's team. Andrew indicated that the Petitioner proposed to rezone an approximately .4-acre site (the "Site") (2712 North Davidson) from the R-5 zoning district to the UR-2 CD zoning district. Andrew explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and the conditional site plan and respond to questions and concerns from nearby residents and property owners. Andrew provided background information about the Petitioner's experience. He then presented the site plan and pointed out various commitments made by the Petitioner. Andrew showed proposed architectural elevations and discussed the design of the proposed facility. He used the elevations and renderings to explain the facility's design concepts, and operations. The NoDa NBA minutes of the conversation about the rezoning are included below:

# MEETING MINUTES FROM 9/3/2019

- 1) Rezoning 2019-094 (NoDa Flats), 2<sup>nd</sup> Presentation & VOTE Andrew Parker
  - a) PRESENTATION
    - i) 6 units along North Davidson. Very similar to the units already on the other side of the creek. Trash will be one receptacle per unit. Natural filtration of storm water with landscaping and such.
    - ii) 3 bed / 3.5 bath, balconies, garages, etc. Developers shared some aesthetics and internal shots.

- iii) Read through NoDa Vision plan:
  - (1) Arts sculpture by Ashley Knight (hopefully). They have a \$7500-10k budget.
  - (2) Pedestrian Safety widen sidewalk, lighting, etc.
  - (3) Slow Traffic not a lot of development along this strip currently, hoping that the building/neighbors will automatically help. Will perform CDOT survey required.
  - (4) Neighborhood Aesthetic trying to match with 36<sup>th</sup> and Holt, Yards, Steel Gardens, etc.
  - (5) Greenification planting new/tree saves where possible, energy efficiencies, etc.
- b) QUESTIONS FROM NBA
  - i) AM1 Last month you mentioned a wall for art along the sidewalk, still in the plan?
    - (1) Plan changed a bit due to pedestrian safety concerns, so we switched gears and are going down the sculpture route.
  - ii) AM2 One car and two car garages for units, but are there visitor parking spots?
    - (1) 6 units total with their garages, plus 5 visitor spots on site (on parcel, not on-street). Still waiting on first comments back from City; we want to leave tree so cutting the other possible two spots out.
- c) INTERNAL DISCUSSION
  - i) No comments.

Motion: to approve petition as presented, with caveats. *Motion Passes (37,1,1)*.
